### **DUES SCHEDULE**

Any member of Local 18, 18A, 18B, 18C, 18D, 18G, 18RA or 18S who does not have his/her current dues paid may be suspended. Dues are payable on a quarterly basis on the first day of each quarter (30-day grace period), with the exception of 18D and 18S, to be paid on a monthly basis.

The quarterly and monthly dues schedule for Local 18 and its Branches and Owner/Operator members is as follows:

Local 18 \$66.75 per quarter +2.5% Administrative Dues\*

Local 18A \$66.75 per quarter +2.5% Administrative Dues\*

Local 18B \$66.75 per quarter +2.5% Administrative Dues\*

Local 18C \$51.75 per quarter (Shops) +1.5% Administrative Dues\* only when working for Dealer/Rental Shops. 2.5% Administrative Dues when working for other shops, i.e., Highway Heavy Companies\*

Local 18C \$57.75 per quarter (Stone Quarries, Material Yards, etc.)

Local 18D \$24.50 per month

Local 18G Two times the employee's hourly rate per month to be paid quarterly

Local 18RA \$66.75 per quarter +2.5% Administrative Dues\*

Local 18S Two times the employee's hourly rate plus \$10.00 per month to be paid monthly

Owner Operator members \$150.75 per quarter

Reduced Dues \$45.75 per quarter

Contributions or gifts to I.U.O.E. Local 18 are not deductible as charitable contributions for federal income tax purposes.

\*The Executive Board, at its January 25, 2020 meeting, approved a resolution to Article VIII, Section 1, of the Bylaws, decreasing the administrative dues to 2.5% of gross wages for all members of Local 18, 18A, 18B, and 18RA. The Executive Board also approved a decrease of administrative dues to 1.5% of gross wages for 18C equipment shop members. Local 18C Quarry and Sand & Gravel Pit members, Local 18D, Local 18G, and Local 18S members dues will remain unchanged. The decrease is effective on April 1, 2020.

Foltz Welding is working on Energy Transfer's 20 miles of 26-inch hydro testing project from Paulding County to Jackson County, Indiana. Case Boring is working for Michels Pipeline in Florence, Kentucky on 24-inch road bores approximately 300 feet. Right-of-Way Clearing is working for Michels Pipeline in Boone County, Kentucky clearing 2.5 miles. Aaron Enterprises is working for InfraSource in Hamilton County on 4,500 feet of 20inch horizontal drilling. Minnesota Limited is working for Vectren in Montgomery County on 25,457 feet of 20-inch lift and lay.

Michels Pipeline is working for Duke Energy in Florence, Kentucky on 2.5 miles of 24inch steel line. Michels Directional Crossing is working for BP on 700 feet of 6-inch horizontal drilling near Cincinnati. InfraSource Construction is working for Duke Energy on 68,000 feet of 20-inch steel new lay and two stations in Hamilton County, Ohio near Cincinnati. Also in Cincinnati, Andis Clearing is working for InfraSource on 8,500 feet of right of way clearing. InfraSource Construction is working for Duke Energy in various counties in Ohio and Kentucky on integrity digs, emergency response, installing valves, and maintenance of 4- to 24-inch lines.

Cogar Right-of-Way Clearing is working for Integrity Kokosing Pipeline Service in Summerfield. Integrity Kokosing Pipeline Service is working for Antero Pipeline in Monroe County on 11,000 feet of 20-inch new lay and 6,000 feet of poly water line. Charps Pipeline is working for Embridge in various locations on integrity anomaly digs on 36-inch line from Athens to Monroe County and into Pennsylvania, Kentucky, Indiana, and West Virginia.

Workers called 911, and the ironworker was transported to the hospital.

We have a mechanics apprenticeship program and the regular operator program, so if you know any young people who want to be mechanics, have them apply online and give the apprenticeship program a call.

Our Logan Training Center is complete except for landscaping and the top coat of

asphalt. The site is beautiful and functioning very well. I would like to thank the staff for all their work helping to make it happen. Part of that addition included a large shop for our new mechanics program. If you get a chance, stop and look at the site, or better yet, sign up for some classes.

I would like to thank the membership for your continued support of our program. Please sign up for classes, and if you have any questions or suggestions, give us a call. his head, neck, and legs.

To prevent an injury of this nature, make sure chokers are properly seated in the hook and that all safety latches are functioning properly. Another way to prevent injury is to stay out from underneath a crane's load. An operator could swing slightly to the side after hooking up the first piece and, while keeping the load low, allow the ironworker to hook the second piece without being under the first piece.

Please contact your district office if you see an accident. Hopefully, we can learn together how to prevent future accidents.

With the roll-out of the vaccines to combat COVID-19 still in its infancy, companies and employees are still very hesitant about going back to their offices to work, and in some cases, companies have changed their business model all together. We are starting to see building occupancies rise, but only slightly. 2021 will be a busy year for Local 18S business agents and our members. Wages and healthcare costs remain the main topics at the bargaining table, with the effects of COVID-19 still lingering.

One group of stationary engineers that Local 18S represents is employed by Jones Lang LaSalle, working in four separate locations in and around Cleveland at PNC Bank main locations. Currently, there are 17 Local 18S members working in four classifications of chief engineer, stationary engineer, maintenance mechanic, and maintenance mechanic assistant. All together, they maintain the approximate 1.4 million square footage of building space. The members are in charge of all aspects of heating and cooling, maintenance, including work such as locksets, carpentry, and light electrical, as well as coordinating all subcontractor work that is needed in the buildings and annual testing that is required for life safety.

Another group of stationary engineers represented by Local 18S is employed at Hepner Air Filter. Currently, there are six members employed at the family-owned company that opened its doors in 1949 by Ray Hepner. The members work all facets, including cleaning used air filters as they come in, fabrication of specialty filters, going out on site for delivery, installation of filters, and maintenance of equipment relating to the filtration systems.


In the beginning, the company's main focus was as a cleaning service for panel-type grease and air filters. The tried-and-true philosophy of providing excellent customer service has once again served well. Now, 72 years later, Hepner Air Service Inc. is owned and operated by Ray's grandson, Eric Hepner, and is a worldwide supplier and manufacturer of quality engineering filtration products and has a very well-respected reputation in the industry.

Throughout the years, Hepner has diversified not only with air filters, but also filters for gas, chemical, and liquid applications. With well over 125,000 filters in stock for various products, including fuel, HEPA, hospital grade, food processing, welding, foundries, and painting industries, just to name a few. Again, keeping the customer in mind, Hepner now has the ability to recycle air filters, which can clean existing air filters, giving them a 99% efficiency rating for less than half the price of a new air filter.

Participants who complete the screenings will receive a \$25 CVS gift card in the mail from the Health and Welfare Plan.

Make the most of your coverage. Keep in mind that your coverage administered by Medical Mutual includes many resources and tools to help you stay healthy and manage your healthcare plan. Log in to My Health Plan, a secure member website, to access the status of your deductible and coinsurance, view your Explanation of Benefits (EOB) statements, search for in-network providers, hospitals, and facilities to maximize your benefits, and find the care you need. You can also learn about wellness programs and preventive care and connect to the Bravo wellness portal to check out recipes, interactive fitness challenges, online courses, and videos.

If you do not have a My Health Plan account, you can register by visiting MedMutual.com/Member and clicking on register for an account. Be sure to have your Medical Mutual ID number handy to create your account.

The Pension Fund has rebounded nicely following a volatile period at this time last year. The trustees and fund professionals never stray from continually monitoring the markets and environment to ensure that benefits will be available for retirees and active members in the future. The net assets of the Pension Fund were more than \$3 billion at the time this article was published, and the Fund is paying out \$13.2 million monthly, or \$158.4 million annually, to 7,433 retirees and surviving spouses.

The Education and Safety Fund scholarship program continues to provide training and educational opportunities for Local 18 members and their qualified dependents. The Education and Safety Fund had paid out more than \$860,000 in educational benefits during the current academic year.

For the 2021–2022 academic year that begins June 1st, the Education and Safety Fund Trustees have awarded \$3 million in scholarships to 887 eligible applicants. Of these applicants, 170 were granted industry-related awards for members and dependents pursuing an education in the construction industry. In addition, the trustees selected five dependent children of Local 18 members to be awarded a special scholarship for essays they wrote explaining why they are pursuing an education in a construction-related field. These recipients will be recognized at the Semi-Annual State Membership Meeting in Columbus, Ohio on Sunday, June 27, 2021.

The following is an updated report of activities regarding pending cases with Local 18 and its members since my last report in January 2021.

LOCAL 18 v. TEAMSTERS LOCAL 100 & LABORERS LOCAL 534 (Stein, Inc. ULP): After Stein, Inc. recognized Local 18 as the majority representative of its employees, both Teamsters Local 100 and Laborers Local 534 filed unfair labor practice charges ("ULP"). The National Labor Relations Board ("Board" or "NLRB") issued an order finding a breach in the National Labor Relations Act ("NLRA"). The Union and the employer have since filed independent appeals of the Board's order in the United States Court of Appeals for the District of Columbia Circuit. Those appeals remain pending.

LOCAL 18/Mike Hood v. CUMMINS, INC. (Grievance): Local 18 filed a grievance challenging the employer's decision to assign bargaining unit work to an employee from Indiana that is not a member of the Union. An Arbitrator was selected, a hearing was held, and post hearing briefs were submitted. The Arbitrator issued an Opinion & Award affirming the Union's grievance in its entity. Recently, the Union was able to determine the amount and proper apportionment of damages resulting in additional back-pay for members of the bargaining unit.

**LOCAL 18 v. ISRAEL SWORD (DOE Complaint):** Union member Israel "Bo" Sword filed a Complaint with the Department of Energy ("DOE") which alleges, inter alia, that Local 18 refused to process a grievance after he was subjected to a layoff by a contractor working at a DOE project site. The Union has denied all wrongdoing and participated in the DOE's investigatory process. Recently, the DOE dismissed Mr. Sword's charges.

**LOCAL 18 v. ISRAEL SWORD (ULP):** In addition to his Complaint with the DOE. Mr. Sword also filed a ULP charge with the NLRB alleging a breach of the Union's duty of fair representation. Recently, the Board issued a Complaint alleging that Local 18 breached its duty of fair representation. The Union has denied all wrongdoing and is defending the matter at a hearing before an Administrative Law Judge

LOCAL 18/Harold Rainer v. ANHEUS-ER-BUSCH/IN-BEV: Union Steward Harold Rainer filed a grievance challenging the employer's method of determining annual production bonuses for the bargaining unit. An arbitrator was selected, a hearing was held, and post-hearing briefs were submitted. Recently, the Arbitrator issued an



Opinion & Award granting, in part, the Union's grievance and awarding every member of the bargaining unit an additional lump sum payment.

**LOCAL 18 v. HEIDI REAMS:** Former Union employee Heidi Reams filed a complaint with the Equal Employment Opportunity Commission ("EEOC") alleging that she was terminated due to a disability. The Union has denied all wrongdoing and participated in the EEOC's investigatory process. Recently, the EEOC ceased processing the charge and provided Ms. Reams with a six (6) month window to pursue a claim in court.

LOCAL 18 v. STEVEN HANK (State Court Complaint): Local 18 member Steven Hank filed a charge with Ohio Civil Rights Commission ("OCRC") alleging that Local 18 engaged in discriminatory conduct. That case was eventually litigated in federal and state court. After extended litigation, Mr. Hank voluntarily dismissed his claims. Recently, Mr. Hank refiled his Complaint in state court. The Union has once again denied all wrongdoing and is once again vigorously defending that claim.

**LOCAL 18/Nate Muhammed v. NORTH-EAST OHIO REGIONAL SEWER DISTRICT:** The Union filed a grievance challenging the employer's decision to terminate Mr. Muhammed's seniority. The matter has since been referred to arbitration. An arbitrator has been selected and a hearing date has been set.

LOCAL 18 v. DEBORAH BEHELER (ULP I): Union member Deborah Beheler filed an unfair labor practice charge with the NLRB alleging that Local 18 refused to process her grievance for arbitrary or discriminatory reasons and operated its hiring hall in an arbitrary, discriminatory and/or bad faith manner. The Union has denied all wrongdoing and is participating in the Board's investigatory process. LOCAL 18 v. DEBORAH BEHELER (ULP II):

Union member Deborah Beheler filed a second unfair labor practice charge with the NLRB alleging that Local 18 again operated its hiring hall in an arbitrary, discriminatory and/or bad faith manner. The Union has again denied all wrongdoing and is again participating in the Board's investigatory process.

**LOCAL 18 v. ALAN STONE, INC.:** The Union filed a grievance challenging the employer's use of a non-signatory subcontractor. The matter was resolved through a settlement agreement reached between the Union and the OCA. The employer, however, has refused to comply with that settlement. As a result, the Union was forced to file a Petition in federal court to confirm and enforce the settlement award.

**LOCAL 18 v. 1100 SUPERIOR, INC.:** The Union filed a grievance challenging the employer's decision to refrain from paying overtime for certain assignments. The matter has since been referred to arbitration. An arbitrator has been selected and a hearing date is being scheduled.

LOCAL 18 v. INFRASOURCE (Grievance): The Union filed a grievance challenging the employer's decision to end a Union member's employment. An arbitrator has been selected and we are in the process of selecting a hearing date.

**LOCAL 18 v. BORDEN DAIRY CO. (ULP):** During negotiations for a new CBA, the employer utilized various dilatory and bad faith tactics. The Union filed a series of unfair labor practice charges with the NLRB challenging the employer's unlawful actions. The employer immediately ceased their unlawful behavior and the charges have been withdrawn provided the parties are able to reach a final agreement on a CBA.

LOCAL 18/Bernard Gray v. CUYAHOGA MUNICIPAL HOUSING AUTHORITY: The Union filed a grievance challenging the employer's decision to terminate a Union member's employment. We are in the process of selecting an arbitrator.

**LOCAL 18 v. SOFIDEL AMERICA. (ULP):** During negotiations for a first CBA, the employer provided annual bonuses and benefits to all employees except Local 18 members. The Union has filed a charge with the NLRB alleging that the employer's actions are an attempt to discourage membership in the Union. The Board is currently investigating the matter.



District One is busy as the work season progresses, with many large projects keeping our members working.

In Cuyahoga County, north of I-480 and west of I-271, NES Corp is milling on East 65th St. in Cleveland and crushing asphalt on West 3rd St. in Cleveland. The Ruhlin Company is building a new pedestrian bridge in the North Coast Harbor and bridge repairs on I-90 at East 140th and East 152nd Streets. Baumann Enterprises has vacant structures demo on West 25th St. in Cleveland. Nerone is working on cleaning out the Doan Valley Brooke for the NEORSD and building a new pump station on Dille Rd. in Cleveland. Aggworx and Hydracrete are working on the new Hebrew Academy on Warrensville Rd. in Warrensville Heights. Aggworx also has some interior demolition for Brinks on Oakleaf Parkway in Valley View. Beaver Excavating, Midwest Equipment, and Gem are putting in a new iron ore conveyor system for the Port of Cleveland. ALL Crane is assembling a new Gantry for the Great Lakes Shipyard. Triad Engineering has storm sewer repairs on Castle Ave. in Cleveland. S.E.T. Inc. is replacing the storm sewer on Stearns Rd. in Cleveland.

Chieftain and Keller International are on Cloverleaf Parkway in Valley View, building the new Ferguson Distribution Center. Also, they are performing site work for the new Lincoln Apartments on Scranton Rd. in Cleveland with Keller International and Howards Concrete on site. Roberts Pipeline is performing anomaly digs on East 49th St. in Cleveland Heights. J. D. Williamson is making bridge repairs on Grayton Rd. over I-480 in Cleveland. Northeast Ohio Trenching has some sewer repairs at the University Heights Shaker campus. The Doan Valley Storage Tunnel is ongoing in University Circle and is being constructed by McNally/Kiewit DVT JV and Northstar Contracting. The Westerly Storage Tunnel has many members busy with Jay Dee Obayashi along with subcontractors Northstar Contracting, Maxim Crane, Marra Services, and Michels Foundation Corp. F. Buddie has some concrete repairs for Saint Christopher Church on Detroit Rd. in Rocky River.

District 2 has seen some major building projects, such as the \$800M expansion at the NorthStar Blue Scope Steel Plant in Delta. This project has provided many operating engineers with good work hours. Still, highway work is the staple of our industry that will provide consistent work hours far into the foreseeable future. Being proficient on equipment utilized on highway projects is a way to insulate yourselves from market instability like what we saw last year due to COVID-19 restrictions. Many building projects were either shut down, delayed, or scaled back to the point that operating engineers who've done mostly this type of work have seen one of the slowest years in recent memory. In contrast, highway work continued without so much as a slowdown. Attend your training sites to brush up on your current skills and attain new skills. May you have a safe and prosperous work season.

## Here are some of the projects happening in District 2:

Degan Excavating is currently finishing up work on the O.B. Frails subdivision improvement project in Allen County. Several operating engineers kept busy these past handfuls of months installing over 18,000 feet of 12-, 15-, 18- and 24-inch storm sewer pipe. They also installed 68 new catch basins, 58-yard drains, cleaned approximately 1,300 LF of ditch, as well as 5,900 LF of storm sewer.

Shelly is currently finishing up work on the I-75 major reconstruction project in Beaverdam. This project addressed two major issues: merging traffic onto I-75 southbound and tractor trailer rollover issues. To correct the merging issues from Beaverdam onto I-75 southbound, ODOT increased the length of the merging lane onto I-75 southbound. This gives motorists more time to find an opening and merge more fluidly into traffic. To address the tractor trailer rollover issue, ODOT increased the superelevation, or banking, of the sweeping curve in both the north- and southbound sections of I-75 just south of Beaverdam. This, along with a slight re-alignment of the curve, should greatly reduce the

number of roll-over incidents on this section of I-75.

M&B Asphalt is resurfacing U.S. Rt. 23 from Fostoria south past U.S. Rt. 224/U.S. Rt. 23 intersection, BCC-Ohio reworked some culverts, Ebony Construction performed the milling, Smith Paving & Excavating installed the curbs and ramps, Miller Cable installed signal loop and Lake Erie Construction will install the guardrail, raised pavement markers, and seeding. getting unpacked and finding the best way to utilize the space. The nearly 40-acre property off of Eckel Junction Rd. in Perrysburg, consisting of The Ohio CAT Rental Store and Northern Ohio Peterbilt, all on one campus, lights up like an airport in the night sky. The complex consists of a 65,250 sq. ft. building including shop space, a parts warehouse, and office space for Ohio CAT's machine sales, rental, and administrative personnel. Other equipment-related work will be done in an impressive 8,300 sq. ft. wash building with its own office and breakroom and a 5,940 sq. ft. cold storage structure. Despite the continuing COVID-19 pandemic, work being done by Operating Engineers in District 3 presses on. Kokosing Construction has several operators on their two ODOT projects in downtown Columbus. The first is the "2-E" project, where I-70 and I-71 intersect. It's a major reconstruction/realignment with cast in place and MSE retaining walls. There were multiple bridge demos with new, redesigned replacements, which include the flipping of Parsons Ave. from an overpass to an underpass. Subcontractors have included U.S. Utilities Contractor Co., Lake Erie Construction, Turn-Key Tunneling, Capital City Group Crane Rental, Danbert, KD Complete Clearing, Miller Cable, M P Dory Co., and Phenix Stabilization. The second project is the Broad St./I-71 Columbus Crossroads. This project includes reconstructing the Broad Street Bridge over I-71, the elimination of entrance and exit ramps, lane additions, and retaining walls. Subcontractors include M P Dory Co., Complete General Construction, Armstrong Steel, Paul Peterson Company, and West Fairfield Inc.

Shelly & Sands continues their work on I-71, south of I-70. This three-year project has gone well, keeping several Operating Engineers busy with day and night shifts. Work includes lane additions, interchange reconfigurations, and the reconstructing of fifteen bridges. Subcontractors include The Ruhlin Company, Complete General Construction, Lionel Construction, Lake Erie Construction, Capital City Group Crane Rental, and KD Complete Clearing. Finish paving continues, and the project should be completed this summer.

Work at The Ohio State University is absolutely booming with multiple major projects, including the expansion of the Wexner Medical Center main hospital, the new OSU/ Nationwide Children's Hospital Ambulatory Center, an animal research center, a large greenhouse, and an additional steam/power plant. It was announced that there are four to five additional projects slated to start this year. The George J. Igel & Co. has had several projects on the OSU campus this season. They also have the site work for the Hilton Hotel/

Columbus Convention Center expansion. When completed, this Hilton will be Columbus' first 1,000-room hotel. Donley Concrete, Maxim Crane, Goettle, and McDaniel's Construction are subcontractors. As the winter months got behind us and the warmer weather approached, work in the district picked up quickly. Several projects remained to be finished from last season that the winter weather had shut down late last year. This gave an early start to many of our members for district recalls and many new dispatches as well. Many new projects were awarded last year and in the first guarter of this year that gave many employment opportunities as well. The projects varied from water main and sanitary sewer replacement to upgrades to a furnace rebuild at the steel mill. Even in the ugly weather, we had several crews that were brave enough to work outside and managed to get time in between the snow and ice storms.

#### **Northwestern Counties**

The Shelly Company kicked off their 2021 asphalt paving with an overlay project at the Indian Lake State Park. Shelly milled over 1,000 sq. yards of existing asphalt and laid 5,900 tons of new asphalt to complete this project. The Shelly Company also has begun the asphalt resurfacing project in Celina. This project will consist of overlaying a mutable number of streets throughout the city. In Champaign County, A&B Asphalt has completed a project on Runkle and Heck Hill Rds. The existing shoulders were widened 2 feet and filled with base asphalt that allowed the surface asphalt to be laid, giving each lane of traffic more room in this rural area. The Shelly Company is working on State Routes 29 and 296 in Champaign County on an asphalt overlay project. J. Milling was on the project in May milling 9,000 sq. yds. of the old pavement. Upon completing the milling, The Shelly Company then placed over 19,000 tons of intermediate and surface asphalt. To the west in the City of Sidney, Barrett paving will start the 2021 asphalt resurfacing project. Welfle will be milling over 400,000 sq. yards for this job, and Blue Ridge Custom Sweeping will perform the sweeping of asphalt millings. After the streets are swept, Barrett Paving will lay 39,000 tons of surface asphalt. In Clark County, on S.R. 235 just

north of New Carlisle, Barrett Paving has laid over 7,500 tons of asphalt. Blue Ridge Custom Sweeping was on site in the spring to perform the power sweeping. Also, in Clark County, Kinnison Excavating is working for the City of Springfield on a water service replacement project. On this job, Kinnison will replace 320 existing lead pipe services with new 3/4-inch copper lines and will also upgrade the water meters. On I-75 in Springfield, John R. Jurgensen continues with an interstate widening project. Over the past few months, the company has moved 30,000 vards of dirt and installed six new MSE walls. John R. Jurgensen has installed a new sound barrier wall that consisted of 139 drilled shaft foundations, along with 400 panels that were set to complete this part of the project. Working for John R. Jurgensen, Double Z is rebuilding three bridges on this project. Throughout the spring, Capital City Crane has been on site setting the beams for Double Z on the bridges. In early spring, Mt. Carmel Stabili-

zation had cement stabilized the new road base, and then John R. Jurgensen had fallowed with the gravel base in preparation for the new asphalt. In July, John R. Jurgensen will be flipping traffic on this project to allow for the final phase of work to start. On I-75 in Miami County, Barrett Paving is working on an asphalt resurfacing project. BOCA will be milling the existing surface as a subcontractor, and Barrett Paving will lay the new asphalt. After the 7,200 tons of asphalt are laid, BOCA will return to mill in new rumble strips on this project. Great Lakes continues with the new Taxiway project at the Darke County Airport, and Donegal Construction, as a subcontractor, milled over 10,000 sq. yards of the existing asphalt early this spring. Great Lakes then laid stone for the new 4,500-foot taxiway, and Ebony Construction will be on site over the summer laying a total of 7,000 tons of asphalt. In Montgomery County, several contractors are busy with ODOT projects. In continued on page 29

Also, any worker involved in an on-the-job accident or whose behavior raises reasonable suspicion of drug and/or alcohol use while on the job will be required to test for drugs and/ or alcohol.

### A drug-free workforce is bound to be safer, more productive, and higher-skilled.

If you aren't aware, any positive test, adulterated test, and/or refusal to test makes someone not eligible to register, train, and work within Local 18's jurisdiction until they have successfully completed Local 18's drug/ alcohol rehabilitation program. Continuation of a problem on the job sites, any positive drug and/or alcohol test result after the second rehabilitation procedure, leaves workers permanently barred from registering on the Local 18 referral. Don't let that be you! Local 18 needs good operators.

# New deal infrastructure projects changed America

Some observers have drawn historical parallels between major infrastructure projects done during President Franklin Roosevelt's 'New Deal' (designed to lift the U.S. out of the Great Depression) and the recent infrastructure plan proposed by President Biden (designed to help the U.S. rebound from the COVID-19 Pandemic). According to an article by Becky Little on the *history.com* website, many of the New Deal projects "remain part of the U.S. landscape"– and nine in particular "show how transformative the New Deal was for America."

- Hoover Dam Located in the Colorado River's Black Canyon, on the border between Nevada and Arizona, today it generates enough hydroelectric power per year to serve 1.3 million people.
- Triborough Bridge The finished bridge connects the boroughs of Manhattan, the Bronx and Queens.
- San Antonio River Walk The City of San Antonio built bridges and pathways that made the area more walkable and allowed businesses to move into the area. Today, the River Walk is a major commercial and tourist hub for the city.



- 4. LaGuardia Airport The New Deal "Works Progress Administration (WPA) funded the construction or improvement of roughly 800 airports, and one of the biggest ones the WPA helped build was LaGuardia Airport in Queens, New York.
- Chickamauga Dam New Deal legislation created a public corporation to improve the Tennessee Valley. Before the dam's completion in 1940, the surrounding region frequently suffered from expensive

flood damage and mosquito-borne illnesses like malaria and yellow fever. By controlling the river's water levels, the dam has prevented billions of dollars in flood damage. It also helped reduce mosquito populations in order to fight the diseases they spread.

- 6. Lincoln Tunnel This project allowed drivers to travel between New York and New Jersey under the Hudson River
- New Orleans City Park This construction likely provided work to tens of thousands of people during the Great Depression, and also benefited residents by providing them with an improved public space.
- 8. Bay Bridge The San Francisco-Oakland Bay Bridge opened in 1936 -- with its eight-mile span, the Bay Bridge was at that time the longest bridge in the world.
- 9. Arroyo Seco Parkway The New Deal was also responsible for the first freeway, which connected Los Angeles to Pasadena. The freeway opened to traffic between 1938 and 1940, and reduced travel time between L.A. and Pasadena from 27 to 12 minutes.

## Offshore wind companies and labor unions could benefit from partnerships

According to a recent article by Margaret Jackson and Maria Castillo on *atlanticcouncil. org* – the website of the Atlantic Council, a nonpartisan organization that galvanizes U.S. leadership and engagement in the world, in partnership with allies and partners, to shape solutions to global challenges – President Biden's plans to "jumpstart" the offshore wind industry in the United States could benefit the wind industry, organized labor, and the 'green' recovery.

"The White House just released a plan to 'jumpstart' the offshore wind industry in the United States, as one of the major catalysts to fulfill the campaign promise to boost the energy transition and create ten million clean energy jobs in the process. Within the first week of his presidency, President Biden issued an executive order that outlined jobs as a central pillar to developing clean energy. His administration is adamant that a sustainable energy transition and his 'Build Back Better' plan must support job creation and specifically, union labor," wrote Jackson and Castillo.

"Offshore wind is especially well-positioned to fit this mission for reasons beyond its growth potential and role in decarbonization. Due to offshore wind's labor-intensive manufacturing, transport, and operation, abundant job opportunities exist across all wage levels and aspects of the offshore wind development and deployment value chain. As the United States faces an economic crisis that has cut employment in the national workforce at a devastating rate, especially for Black, Latino, and women workers, offshore wind expansion could provide job opportunities for those communities hit hardest by the pandemic and set the country on a path to economic recovery," the authors wrote.

"Unions and offshore wind companies both derive respective benefits from working together and such a partnership could serve as an influential example in the development of other opportunities for union work across the clean energy sector, which has received skepticism from labor groups due to lower wages and unionization rates. As the offshore wind industry matures in the United States, the benefits will extend as far as steel manufacturers in Kentucky to ship builders in the Gulf of Mexico," wrote Jackson and Castillo.

"As companies in sectors across the country establish and embrace clean energy goals, an important trend is developing: unions are moving forward with union-company agreements for the first time. Such partnerships can ensure opportunities for union labor, provide necessary skills train-

ing, set high safety standards, and promote a more diverse workforce," the article continued – citing as one example, the Labor Energy Partnership, chaired by Ernest Moniz, former Secretary of Energy and current President of the Energy Futures Initiative, and Richard Trumka, president of the American Federation of Labor and Congress of Industrial Organizations (AFL-CIO), which is working to create a pipeline for union workers to enter the offshore wind sector and ensure they earn a just and living wage. According to the article, other union labor and offshore wind company partnerships at different stages of the supply chain are already showing signs of success – such as a partnership in Virginia with Dominion Energy and three labor unions—the Virginia State Building and Construction Trades Council, the International Brotherhood of Electrical Workers, and the Laborers International Union of North America Mid-Atlantic Region.

"For these partnerships between offshore wind companies and labor unions to move forward and bring more economic and employment opportunities to local communities, governmental entities must create pathways through ambitious legislation and regulation. Many offshore wind companies currently are stuck in the permitting process and eager to get their projects started along the coastal states. Serious momentum to grow renewable energy, and especially offshore wind capacity, is building at the federal, state, and local levels. Labor unions and offshore wind companies are ready to propel the country to meet its clean energy goals while providing well-paid work to Americans along the way," concluded the authors.

The Campbell Soup Plant will have access to highway and rail infrastructure, and nearly 44% of Henry County workers, whose jobs are located within 1 mile of the new bridge, will have a more efficient route to work.

Roughly \$700 million have been financed to fund the North Star Blue Scope Steel Plant

expansion in Delta. However, the price tag has since grown to above \$800 million. Rudolph Libbe is overseeing the project and performing the site work. The project will add a furnace and a slab caster to production. Jeffers Crane Service, Capital City, Don Fruchey Inc, Dunbar Mechanical LLC, Gurtzweiler, and GEM have been brought in as subcontractors. The addition of the Melt Shop is expected to be operational by July of 2021 and will add 950,000 metric tons of steel to the 2.3 million metric tons North Star already produces *continued on page 22*

annually, an increase of about 40%. Separately, IPS has also picked up a substantial amount of work at North Star that will keep our members busy.

Just off of S.R. 109 and the Ohio Turnpike, Mosser has completed the site drainage and prep work on the \$70-million construction of Nova Tube and Steel's new facility in Delta. Signatory contractor, Ten Mile Creek has been brought in to perform stabilization at the site, and Foundation Steel has been awarded the structural steel. Nova Tube and Steel is a Canadian-based company that processes and distributes carbon steel, stainless steel, and aluminum products and operates as an intermediary between primary metal producers and manufacturers. The plant will be 250,000 sq. ft. and will utilize the latest advanced manufacturing technology with an Ohio workforce to support growing demand in the North American market.

In Edon, Beaver Excavating Company has been awarded an eight-mile stretch of roadway reconstruction of the right two lanes and shoulder in both directions between mile marker 0 and 8.2 of the Ohio Turnpike. The work includes widening the inside lanes to the median with an additional lane and shoulder in both directions. Beaver will employ fifteen to twenty operators on this job. This project is expected to take three years, with a toll booth being added in the final phase, which has not yet been awarded.

Kokosing's I-75 major reconstruction project from Wales Rd. up to Dorr St. in Toledo, Northwood and Rossford is seeing some progress. The five-year mega project will widen I-75 to three lanes in each direction, along with some other configurations that will enhance safety. Work on this project includes the following:

- Widen and reconstruct I-75 to current standards, including reducing the curve between Wales Rd. and Miami St.
- Reconfigure I-75 interchanges with the Anthony Wayne Trail, South Ave., and Miami St.
- Replace the I-75 (DiSalle Bridge) over the Maumee River.

The DiSalle Bridge is by far Toledo's busiest Maumee crossing, with more than 75,000 cars and trucks on a typical day. The project, which is running on schedule, is expected to be completed in 2023.

Miller Brothers Construction continues working on a major project of widening of about three miles of I-475/U.S. Rt. 23 in western Toledo and Springfield Township, which started in 2019. The project will add a third lane to Toledo's western beltway in both directions between Central Ave. and Airport Highway. Crews continue working on drainage, water line, and roundabouts on Dorr between Holland-Sylvania Rd. and McCord Rd. Overall construction is expected to be completed by late 2022. ODOT divided I-475 widening plan into three separate projects:

- Project A Miller Brothers Construction widened five main line bridges and 1.2 miles of I-475, finishing the project in 2017.
- Project B Miller Brothers Construction started construction in November 2019 and is on schedule to open the new interchange and roadway to traffic in late 2021.
- Project C A separate planned project to add an interchange at U.S. Rt. 20A and widen four miles of I-475 is scheduled to start in 2022.

In the spring of 2020, Toledoans got to see the first stage of the Summit Street Beautification Project between Lafayette and Jackson Streets. Construction started with replacement of a water main below, along with old trolley tracks beneath the street. The tracks were embedded in a layer of concrete thick enough to lead city officials decades ago to believe that it would be cheaper and easier to just pave the street thicker over them rather than remove them.

Contractor Crestline Paving of Toledo has returned to complete the project. Summit's reconstruction will provide wider sidewalks, more curbside parking, and a median that will be wide enough between Madison Ave. and Adams St. to accommodate an area with a raised deck, decorative lighting, and public artwork. Summit St. is currently closed and will open again when construction is complete this fall.

Also, in Fremont in 2020, Mosser Construction completed Phase One of a roadway

reconstruction project to a major entryway into the City of Fremont. In Phase One, Mosser started at North St. and worked towards Miller Street. Phase Two has begun and will continue from Miller St. to State St. Improvements will include water line, sewer, and storm line replacement along with resurfacing and curb to extend the full length of the project with median islands.

Great Lakes Construction has started working on a new stretch of noise wall in *continued on page 24*

Sylvania. Preliminary work included drilling the shafts for the wall foundations. While many of the noise walls are associated with roadway widening, this project's purpose is to mitigate the sound of roadway traffic solely. This project has an expected August 2021 completion.

Vernon Nagel is currently working on a three-month closure of the Fallen Timbers Lane Bridge over U.S. Rt. 24 in Maumee. The closure is for bridge rehabilitation, including bridge deck replacement, substructure rehabilitation, raising the vertical profile, and all bridge approach adjustments. The bridge is expected to open by Memorial Day.

In Sandusky County, there will be improvements to the Ohio Turnpike ramp over S.R. 53, Fangboner Rd., and the ramp over Exit 91.

Kokosing Construction began work in early April that involves removing the Ohio Turnpike Bridge over S.R. 53, replacing the ramp bridge and the S.R. 53 interchange with a roundabout. Also included is deck replacement of the Fangboner Road Bridge. This project has an estimated completion date of October 31, 2021.

The sidewalk behind ProMedica's headquarters at the former steam plant near downtown Promenade Park has been closed

for nearly two years due to structural issues. Miller Brothers Construction and the George Gradel Company are currently rebuilding the retaining wall and sidewalk next to the Maumee River. After construction is complete, the Toledo Metroparks will start planning for a pedestrian bridge project to connect the city on both sides of the river. With what looks like a lot of good work this year in District 2, the operating engineers will be ready to get back out in the field and do what we do best. Be the hardest working, most highly trained, and skilled workforce we can provide to our signatory contractors, all while doing it safely. Good luck and may this work season be a fruitful one.

### DETAILS ON OHIO'S NEW TRANSPORTATION BUDGET: Billions committed for road and bridge work and related employment

It's true that IUOE Local 18 members are working on various transportation projects across the state. A look at Ohio's latest biennial transportation budget, however, can provide a clearer and more comprehensive picture of what type of work is being prioritized, where new work will likely come from, and how both will contribute to union employment.

#### The state is investing more than \$5 billion into road and bridge projects that will help provide jobs for union members, tradesmen and tradeswomen.

#### Included in the \$8.3 billion transportation budget:

• \$318 million for highway safety projects

- \$2.6 billion for other state-maintained roadway improvements
- \$2.4 billion for local roadway improvements
- \$116 million for the Public Works Commission, including \$14 million for emergency road-slip repair

#### Additional features:

- \$74 million earmarked for public transit projects
- \$8 million in grants from the federal EPA for electric vehicle charging stations throughout the state

#### **Big picture thinking:**

Besides committing funding for transportation projects, the biennial budget also includes a number of other provisions that may boost construction.

- The budget calls for a dramatic increase to the financial limits on when local road and bridge projects must go through competitive bidding. This figure has not changed since 2003, even though construction costs have increased considerably.
- Also included is a spending plan for hundreds of millions of dollars in federal stimulus money, including some to help local governments and transit systems.

As the state says, the transportation budget is not only meant to improve Ohio's road, bridge and related infrastructures — but it is also designed to help strengthen related transportation construction employment.

Clayton, on I-70, Barrett Paving has completed a mill and fill project with BOCA Construction, milling over 230,000 sq. yards of existing asphalt, and Barrett Paving laid 13,000 tons of asphalt. On U.S. Rt. 40, In Vandalia, R.B. Jergens had moved 40,000 yards of dirt and installed 3,000 feet of 16inch ductile water main that allows for two additional traffic lanes to be added to help ease traffic congestion to the industrial park. In April, R.B. Jergens completed the cement Stabilization of 62,000 sq. yards of dirt for the new gravel base, and John R. Jurgensen will be laying the new asphalt for the 1st phase of this project. Located at the crossroads of America on I-70 and I-75 in Dayton, Chagrin Valley Paving just finished up a concrete replacement project with removing 600 yards of existing concrete along with the demolition of a 4-ft. parapet wall, which was replaced with a new 7.5-ft. high parapet wall to comply with new safety standards.

Eagle Bridge is working on two bridge replacements on S.R. 235. The first bridge is located over S.R. 4, and in late winter, the existing bridge deck and I-Beams were removed. The bridge abutments and piers were raised 30-inches to allow for new highway height requirements. Armstrong Steel Erectors has set new galvanized steel beams, and A&B Asphalt will be laying the pavement in early summer to complete this project. The 2nd bridge replacement is just south of S.R. 4 over Mud Run Creek. The existing deteriorated concrete box beams were removed and replaced with new ones. summer. CG Construction and Utilities finished a water main replacement on Gettysburg Ave. in Dayton. The company installed 6,000 feet of 10-inch ductile iron water main and replaced nine fire hydrants. W.C. Jones was on this site replacing the asphalt. The Ruhlin Company started back to work on a bridge replacement project on I-75 over the Great Miami River for ODOT. In late April, State-Wide Concrete Pumping placed 1,200 yards of concrete for the new bridge deck. Ruhlin then slipped formed 1,000 feet of 42-inch parapet wall along the outside edge of the bridge. John R. Jurgensen will be on this project over the summer to tie in the existing roadway to the new bridge with asphalt. After completing the new asphalt, Ruhlin will be flipping traffic for Phase 3 that will allow for the removal of the inside two lanes of I-75 South. 

overlooks and pour new parapet walls and sidewalk along the bridge. In late summer, Ebony Construction will be on site milling and replacing the existing asphalt. Barrett Paving is working on U.S. Rt. 35 East of Smithville Rd. on a roadway widening project. Over the winter, Donald May Construction laid a new storm drainpipe on the east side of the project. In early spring, A&A Safety installed over 20,000 feet of temporary traffic control barrier wall. This allowed Barrett Paving a safe access to the center grass median that will be excavated to add a 3rd lane to accommodate east- and westbound traffic. Phoenix Stabilization was on site in April, stabilizing 54,000 sq. yards of sub-base material with cement. Barrett Paving will then lay a new gravel base and finish paving with asphalt.

#### **Distribution & Maintenance**

Miller Pipeline is busy in Versailles on a gas main upgrade. The company will be installing 4,300 feet of a new larger diame-

Just down the street on Woodley Rd. in Dayton, Premier Energy is installing 3,500 feet of 2-inch plastic gas and has 60 existing residential services to upgrade. KS Energy is working off Edwin C. Moses Blvd. in Dayton, installing 3,000 feet of 2-inch plastic gas main and will be upgrading services to 68 existing homes. Miller Pipeline is working on Grand Ave. in West Dayton, replacing 3,500 feet of 6-inch plastic gas main, and 30 residential services will be replaced. Miller Pipeline Restoration crews are working all over the Northern Counties. The restoration crews will be replacing the asphalt and concrete that was removed during the gas line installation work.

#### Shops

At Columbus Equipment shop in Huber Heights, the mechanics have been busy over the spring getting their customers' machines serviced and ready for the 2021 work season. At Ohio CAT in Troy, the shop mechanics have been working on a complete undercarriage replacement on a D-9 Bulldozer. The field service mechanics have been busy with onsite repairs of various equipment.

# Ohio infrastructure gets 'C-' grade from federal government

#### The Buckeye State's infrastructure has suffered from a "systemic lack of investment."

Ohio infrastructure is in need of repair and investment, according to a federal report. Ohio infrastructure has "suffered from a systemic lack of investment," according to a new report from the federal government.

President Joe Biden's White House staff released a state-by-state infrastructure analysis. In the report, the Buckeye State received an overall infrastructure grade of "C-."

The report was released as Biden's team tries to garner more support for its \$2.3 trillion infrastructure package. Most states received a letter grade on their infrastructure. West Virginia earned a D. So did Biden's home state of Delaware. The highest grade went to Utah, which notched a "C+." The lowest grade, "D-" went to the territory of Puerto Rico.

The Ohio analysis starts by noting that 1,377 bridges and 4,925 miles of highway in Ohio are in poor condition. Since 2011, Ohio drivers have seen their commute times increase by 5.7 percent. Each Ohio driver pays \$506 annually due to driving on roads in disrepair.

Ohioans spend an extra 75.9 percent of their time commuting when they use public transportation, the report found. Non-white

#### Temporary Extension of Deadlines Due to COVID-19 National Emergency

The federal government announced that the country is under a COVID-19 National Emergency starting March 1, 2020. The period between March 1, 2020 and the 60th day after the announced end of the COVID-19 National Emergency will not count against certain deadlines under the Ohio Operating Engineers Health and Welfare Plan and the Ohio Operating Engineers Pension Plan. The extension applies to deadlines to file a claim or appeal, enroll a new spouse or child, report COBRA qualifying events and to elect and pay for COBRA under the Health and Welfare Plan. The extension also applies to deadlines to file a claim or appeal under the Pension Plan. This may give you a longer time to take certain actions. households are 6.2 times more likely to rely on public transit. Additionally, 16 percent of trains and other public transit vehicles are past their useful life.

Ohio infrastructure is failing in these other ways, the report said:

- 29 extreme weather events have cost Ohio \$10 billion in infrastructure repairs.
- Water infrastructure will require an additional \$13.4 billion in funding for repairs and replacements.
- 681,000 Ohioans spend more than 30 percent of their income on rent.
- 6.8 percent of Ohioans live in areas with no broadband access.
- 58.2 percent of Ohioans live in areas with only one broadband internet provider.
- Low-income Ohioans spend between 8 and 10 percent of their income on energy costs.

Republican lawmakers object to funding the package by increasing the corporate tax rate from 21% to 28% and increasing the global minimum tax, among other tax changes, including stepped-up IRS enforcement being proposed by the Biden administration.

The federal analysis of Ohio infrastructure aligns with the 2021 Report Card for Ohio Infrastructure from the Ohio Section of the American Society of Civil Engineers. That society also gave Ohio infrastructure a "C-" grade.

Here's how Ohio performed on that report card:

- Bridges: C+
- Dams: C-
- Drinking water: D+
- Energy: C
- Hazardous waste: D+
- Inland waterways: D+

- Levees: D
- Parks: C-
- Ports: C
- Rail: B
- Roads: D
- Schools: C+
- Solid waste: B-
- Stormwater: D+
- Transit: D
- Wastewater: C-

That report noted the extensive cuts to transit funding over nearly two decades, with the state slashing funding from \$42.3 million in 2000 to \$6.6 million in 2018. The state has since reinvested in transit, though COVID-19 hampered those efforts.

"For years, America's infrastructure was the envy of the world. But for too long now, we have failed to invest the necessary resources in our nation's roads, bridges, schools, and technology," U.S. Senator Sherrod Brown said during a February meeting held with the American Society of Civil Engineers.

# This Month in Labor History

#### International Ladies Garment Workers Union Formed in June 1900

Founded on June 3, 1900 in New York City by seven local unions, the International Ladies Garment Workers Union (ILGWU) became one of one of the largest labor unions in the United States with a peak membership of 450,000 in 1969. The ILGWU was one of the first U.S. unions to have a primarily female membership, and was also a key player in the labor history of the 1920s and 1930s. The ILGWU merged with the Amalgamated Clothing and Textile Workers Union in 1995, to form UNITE – and in 2004, that organization merged with the Hotel Employees and Restaurant Employees Union to form UNITE HERE.

### The secret weapon to work site safety and success is a skill we all have

When it comes to safety on the construction job site, we often talk about OSHA guidelines, improved equipment, better technologies and more. But according to a study by the Project Management Institute (PMI), there is one secret weapon that is the most powerful in helping ensure worker safety and project success.

#### It's a weapon we all have: the ability and willingness to focus on communicating with one another.

Why is communication so important? The construction industry is a high-risk work environment. In the U.S., more than 200,000 non-fatal construction injuries are reported each year. Communication that is properly executed on the job can fix most of these challenges. Conversely, lack of communication in construction can be a problem.

#### What we all can do on the safety front

Here are some simple strategies to improve on-the-job communication and safety levels:

- Make sure everyone is familiar with the terminology used for safety training.
- Foster a culture that encourages everyone to speak freely when a hazard is discovered.
- Make safety communications a positive experience. Report not only bad situations but highlight safety actions that are working.
- Keep messaging simple and to the point.
- Tailor your messages to the recipient's level of knowledge.
- Report through the proper channels and to the right person.
- Try to avoid jargon and terminology that might not be understand.
- For important or policy-related communications, augment spoken words with a written document.

## The effects of poor communication on construction success

According to the Project Management Institute, one-third of all projects are unsuccessful due to poor communication among workers and leaders. Even if the project isn't a total failure, the effects of poor communication can still take its toll.



More than half of all project budget risk is due to ineffective communications and improper time management of project communications. — Project Management Institute

#### In projects with minimally effective communications:

- only 37% were completed on time
- only 48% were completed within budget
- just 52% met their original goals

Effective job site communication can be the difference between a profitable and safe project and an unsuccessful one.

# Of projects that had highly effective communication:

- 71% were finished on time
- 76% were completed within budget
- 80% met their original goals

When everyone is communicating and on the same page, mistakes and accidents can often be avoided, employee moral rises, a greater sense of camaraderie is created and everyone feels more valued.


