Dues Schedule

Any member of Local 18, 18A, 18B, 18C, 18D, 18G, 18RA or 18S who does not have his/her current dues paid may be suspended. Dues are payable on a quarterly basis on the first day of each quarter (30-day grace period), with the exception of 18D and 18S, to be paid on a monthly basis.

The quarterly and monthly dues schedule for Local 18 and its Branches and Owner/ Operator members is as follows:

Local 18 \$66.75 per quarter +2.5% Administrative Dues*

Local 18A \$66.75 per quarter +2.5% Administrative Dues*

Local 18B \$66.75 per quarter +2.5% Administrative Dues*

Local 18C \$51.75 per quarter (Shops) +1.5% Administrative Dues* only when working for Dealer/Rental Shops. 2.5% Administrative Dues when working for other shops, i.e., Highway Heavy Companies*

Local 18C \$57.75 per quarter (Stone Quarries, Material Yards, etc.)

Local 18D \$24.50 per month

Local 18G Two times the employee's hourly rate per month to be paid quarterly

Local 18RA \$66.75 per quarter +2.5% Administrative Dues*

Local 18S Two times the employee's hourly rate plus \$10.00 per month to be paid monthly

Owner Operator members \$150.75 per quarter

Reduced Dues \$45.75 per quarter

Contributions or gifts to I.U.O.E. Local 18 are not deductible as charitable contributions for federal income tax purposes.

*The Executive Board, at its January 25, 2020 meeting, approved a resolution to Article VIII, Section 1, of the Bylaws, decreasing the administrative dues to 2.5% of gross wages for all members of Local 18, 18A, 18B, and 18RA. The Executive Board also approved a decrease of administrative dues to 1.5% of gross wages for 18C equipment shop members. Local 18C Quarry and Sand & Gravel Pit members, Local 18D, Local 18G, and Local 18S members dues will remain unchanged. The decrease is effective on April 1, 2020.

By rothers and Sisters, welcome to 2022! We have decided that it is time for a new look for the *Buckeye Engineer* magazine, starting with the new year. This monthly publication has evolved over the years into what you see here today, and we are excited to roll out the new version. Moving forward, we will continue to add new sections and highlight the membership of Local 18, all while keeping you informed about your Local. We will also be exploring options for members to have the ability to opt-out of receiving the printed

version and instead receive an emailed digital version. This option would only apply to members who would choose the digital version, and those who do not would continue to receive this as usual in their mailbox each month.

Local 18 finished the year in great

shape, and we have all of the past officers and staff to thank for setting us up for a bright future. We are excited about all of the things that this new year will bring to this organization. In last year's issues, we shared with you the numbers for the funding on both the state and federal levels for infrastructure, and we cannot wait for the projects to kick off.

All of Local 18's districts will experience numerous projects due to the funding, leading to job opportunities for our members. In order to be prepared for the upcoming work, we encourage everyone to get to your nearest training facility to renew certifications and obtain new ones at the same time.

The largest project we hope to start in 2022 is the highly anticipated Brent Spence Bridge Corridor Project. Opened in 1963, the double-decker Brent Spence Bridge was built to carry 80,000 vehicles a day and now carries twice that volume. An extra lane was added in 1985, but congestion still exists and is getting worse. It has one of the highest crash rates for interstate highway bridges in the nation and has suffered damage due to these crashes.

A \$2.7 billion plan calls for keeping the Brent Spence Bridge and building a new bridge directly next to it, alleviating traffic around the Cincinnati region. This proposal has been on the shelf for years, and the design has been ready to go. There was just no funding to go along with the plan. Now that the federal infrastructure bill has been passed, it can become a reality, and we are ready to build!

Late last year, we also announced a membership software program for all good standing members. We are currently uploading all of the membership records and developing the referral portion as we speak. Once the software is created, we will use it behind the scenes

to ensure the bugs are worked out before rolling it out to the members. When the entire program is complete, it will work within the current Local 18 app and be accessible on the Local 18 website. Having the ability to register for work, check dues status, work history, and access documents online is something we have all wanted for some time now. It is too early for us to have a go-live date; however, we will be sure to notify the membership as soon as we know.

The new year looks bright and should bring numerous job opportunities to all our members. Be sure to mark your calendars for the upcoming membership meetings as well as the semi-annual state membership meeting at the end of this month in Columbus. We will be honoring all our new life membership recipients at the January state meeting, so come on out to help congratulate them.

We look forward to seeing everyone at a union event in the near future. Until then, be safe and look out for one another.

which has enabled us to build relationships with and sign contractors working on these projects and capture the lion's share of the work for the membership of Local 18.

As you have heard before, there has been an issue with a company called Glenn O. Hawbaker in Pennsylvania. They have been found guilty of fringe fraud by the State of Pennsylvania in the amount of \$20.3 million and are on the verge of disbarment in the State. This is causing them to bid more work in our jurisdiction. We are not going to let this stand. We have been working diligently on this and have filed prevailing wage complaints on each project they have worked on in the last two years. We are currently in the process of obtaining information and filing on their current projects. This will continue until they quit bidding work in Ohio, get disbarred by the State, or decide to become a signatory and do things right. I will keep you updated as this situation progresses.

three high-pressure farm tap services, and replacements in Auglaize County. A1 Industrial Resources is working for TC Energy near Wooster on lead line connections of various sizes. Contractors Rental is working on maintenance as well as integrity dig ups in Wayne and Stark Counties. Badger Daylighting is working for Enbridge across the state on several hydro-excavating projects and keeping several operators busy.

Roberts Pipeline is working for Buckeye Partners in Lucas County on integrity and maintenance dig ups.

Gwinnups Restoration is doing work on a couple spreads for TC Energy on the Leach XPress Pipeline. They are working on restoration and environmental cleanup in Noble, Morgan, Perry, Hocking, and Vinton Counties. Union Pipeline is working near Wooster and has several operators working on eight miles of 8-inch new lay for Dominion. Contractors Rental is working for TC Energy in Belmont County on a mile and a half of relay 6-inch steel. InfraSource Construction continues on 68,000 feet of 20inch steel pipe and two stations in Hamilton County at the Cincinnati Corridor.

Minnesota Limited is working for Vectron in Green County on 48,000 feet of 20-inch relay. InfraSource Construction continues emergency response integrity digs installing valves for Duke Energy in Boone and Hamilton Counties, Kentucky. Otis Eastern continues working several crews for Enbridge on various integrity and geohazard repair work across Pennsylvania, Ohio, West Virginia, and Kentucky. Snelson Companies, Inc. is working for Duke Energy in Butler County building a compressor station, and InfraSource is building the second compressor station for the Central Corridor near Madison. Henkels & McCoy is working in Boone & Campbell Counties for Duke Energy on multiple meter stations.

government sources to find fatal accidents, so we are able to learn from them and help our members stay safe. I did this in an effort to educate our members on the devastating and life-changing event

that is involved with a fatal accident. One of the most informative and complete sources for this information is Mine Safety and Health Administration website (MSHA. gov). With the goal of reaching the public with this information, MSHA has developed the "Fatalgram." With its rather morbid name, it leaves no doubt as to the subject matter it discusses. I have four such reports I wish to share with the Brothers and Sisters of Local 18.

On January 19, 2021, at a non-union quarry in Orem, Utah, a miner backed a haul truck to the edge of a dump point that was over steepened by a loader removing material at the bottom of the slope. When the edge of the bank failed, the haul truck traveled backward and overturned, landing on the roof of the cab. The miner was fatally injured.

To prevent an accident of this type:

- Always dump material in a safe location. If ground conditions aren't reliable, dump loads a safe distance back and push the material over the edge.
- Never load material from the toe directly below an active dump point. This may lead to an over steepened and unstable slope.
- Never drive haul trucks beyond cracks on the top of the dumpsite.
- Always construct substantial berms as a visual indicator to prevent overtravel. Clearly mark dump locations with reflectors and/or markers.
- Always wear a seatbelt.

• Maintain communication between equipment operators and loaders.

On March 5, 2021, at a non-union quarry in Mt Sterling, Illinois, an employee was fatally injured when the excavator he was operating rolled over into a body of water.

To prevent an accident of this type:

- Construct berms or install guardrails on roadways where a drop-off exists. Ensure berms and guardrails are at least as high as the mid-axle height of the largest equipment using the roadway.
- Examine and maintain roadways to prevent slope instability such as over steepened banks, sloughs, and cracking on the roadway and bank.
- Always wear seatbelts when operating mobile equipment.
- When working near water, wear flotation devices and ensure combination seat belt cutter/window breaker tools are installed in equipment.

On April 19, 2021, at a non-union quarry in Elsa, Texas, an employee stopped his haul truck in front of his personal truck to get his lunch. While standing and eating his lunch, the haul truck rolled forward, pinning the miner between the haul truck and his personal truck, fatally injuring him.

To prevent an accident of this type:

- Do not leave mobile equipment unattended unless the controls are placed in the park position, and the brake is set. NEVER use a steering column-mounted "dump brake" for parking.
- When parking mobile equipment on a grade, chock the wheels or turn them into a bank. Maintain equipment braking systems in good repair and adjustment.
- Position yourself in a safe location away from potential "danger-zone" areas.

On July 21, 2021, at a non-union surface coal mine in Wright, Wyoming, a miner received fatal injuries while adding a boom extension to a crane. The miner was working under the boom to remove the boom pins when the boom struck him.

To prevent an accident of this type:

- Never perform work under raised machinery or equipment until such machinery or equipment has been securely braced in position, blocked, and secured against motion. Be alert for hazards that may be created while the work is being performed.
- Conduct repairs from a safe location per manufacturer's recommendations. Verify the release of all stored energy before initiating repairs.
- Use a lifting device that is compatible with the load being lifted and ensure that blocking material is competent, substantial, and adequate to support and stabilize the load. Always use the manufacturer's safety devices or features to secure components against motion and secure assemblies that rotate to prevent movement.

I hope that these reports on fatal accidents will give us pause to think about our task at hand and how to do it as safely as possible. The livelihood of our families, our signatory contractors, and our union depends on it. STAY SAFE!

It is that time of year to apply for a scholarship from the Ohio Operating Engineers Education

and Safety Fund. The application period is currently open for eligible members and dependents through April 1, 2022. You can apply online through the member portal at ooexg.com or access the application through the Member Fringe Benefits tab on the IUOE Local 18 app. Applications are also available in all district offices and at the Fringe Office. Applicants pursuing an education in a construction-related course of study may be eligible for a higher award amount. Awards will be granted for the academic year beginning June 1, 2022, and ending May 31, 2023. This is a great program for members and their families to expand their knowledge and sharpen their skills.


The Trustees of the Ohio Operating Engineers Health and Welfare Plan are partnering with Life Line Screening in 2022 to conduct important preventive health screenings to identify underlying risk factors for vascular disease, stroke, high blood pressure, abdominal aortic aneurysms, peripheral arterial disease, high cholesterol, and diabetes, including A1c. These screenings are free of charge to eligible members and their spouses. Please call (800) 697-9698 to schedule an appointment for your screening if you have not already participated. It only takes a few minutes of your time, and it will help you and your doctor make sure you stay healthy. All members and spouses who participate in the screenings will receive a \$25 CVS gift card from the Health and Welfare Plan.

Please be advised that The Centers for Disease Control and Prevention ("CDC") recommends an annual flu vaccine for anyone six months of age and older. This year's flu vaccination offers protection against four of the influenza viruses expected to be circulating during the current flu season. It is not too late to get your flu vaccine, and the Health and Welfare Plan covers them at 100%, up to \$50 per calendar year. In addition, as of November 19, 2021, the CDC recommends COVID-19 booster shots for all adults who have been vaccinated with the

U.S. authorized vaccines. For those who received the Pfizer-BioNTech or Moderna COVID-19 vaccine, the booster shot should be administered at six months or more after the initial series. For those individuals who received the Johnson and Johnson COVID-19 vaccine, booster shots are recommended for those who were vaccinated two or more months ago.

ACA requirements for 1095-B

The following is an updated report of activities regarding pending cases with Local 18 and its members since my last report in July 2021.

LOCAL 18 v. TEAMSTERS LOCAL 100 & LABORERS LOCAL 534 (Stein, Inc. ULP): After Stein, Inc. recognized Local 18 as the majority representative of its employees, both Teamsters Local 100 and Laborers Local 534 filed unfair labor practice charges ("ULP"). The National Labor Relations Board ("Board" or "NLRB") issued an order finding a breach in the National Labor Relations Act ("NLRA"). The Union and the employer have since filed independent appeals of the Board's order in the United States Court of Appeals for the District of Columbia Circuit. Those appeals remain pending.

LOCAL 18 v. ISRAEL SWORD (ULP): Union member Israel "Bo" Sword also filed an Unfair Labor Practice ("ULP") charge with the NLRB alleging a breach of the Union's duty of fair representation. The Board eventually issued a Complaint alleging that Local 18 breached its duty of fair representation. The Union has denied all wrongdoing defended the matter at a hearing before an Administrative Law Judge ("ALJ"). The ALJ recently issued a decision finding the Union in breach of its duty. The Union is in the process of appealing that decision to the Board.

LOCAL 18 v. HEIDI REAMS: Former Union employee Heidi Reams filed a complaint with the EEOC alleging that she was terminated due to a disability. The Union denied all wrongdoing and participated in the EEOC's investigatory process. Recently, Ms. Reams filed a discrimination claim against Local 18 in Federal Court. The Union has once again denied all liability and is defending against the claim.

LOCAL 18 v. STEVEN HANK (State Court Complaint): Local 18 member Steven Hank filed a charge with Ohio Civil Rights Commission ("OCRC") alleging that Local 18 engaged in discriminatory conduct. That case was eventually litigated in federal and state court. After extended litigation, Mr. Hank voluntarily dismissed his claims. Recently, Mr. Hank refiled his Complaint in state court. The Union has once again denied all wrongdoing and is once again vigorously defending that claim.

LOCAL 18/Nate Muhammed v. NORTHEAST OHIO REGIONAL SEW-ER DISTRICT: The Union filed a grievance challenging the employer's decision to terminate a Union member's seniority. The matter was then referred to arbitration, an Arbitrator selected, and a hearing has been held. We are in the process of preparing post-hearing briefs to the Arbitrator.

LOCAL 18 v. DEBORAH BEHELER (ULP I): Union member Deborah Beheler filed an unfair labor practice charge with the NLRB alleging that Local 18 18 refused to process her grievance for arbitrary or discriminatory reasons and operated its hiring hall in an arbitrary, discriminatory, and/ or bad faith manner. The Union denied all wrongdoing and participated in the Board's investigatory process. Recently, the Board dismissed this charge due to lack of merit.

LOCAL 18 v. DEBORAH BEHELER (ULP II): Union member Deborah Beheler filed a second unfair labor practice charge with the NLRB alleging that Local 18 again operated its hiring hall in an arbitrary, discriminatory, and/or bad faith manner. The Union again denied all wrongdoing and again participated in the Board's investigatory process. The Board also dismissed this charge due to lack of merit.

LOCAL 18 v. ALAN STONE, INC.: The Union filed a grievance challenging the employer's use of a non-signatory subcontractor. The matter was resolved through a settlement agreement reached between the Union and the OCA. The employer, however, has refused to comply with that settlement. As a result, the Union was forced to file a Petition in federal court to confirm and enforce the settlement award. Recently, this matter was resolved after the employer made payments required by the settlement.

LOCAL 18 v. 1100 SUPERIOR, INC.: The Union filed a grievance challenging the employer's decision to refrain from paying overtime for certain assignments. The matter was referred to arbitration, an arbitrator was selected, and a hearing held. Recently, the Arbitrator issued an Opinion & Award denying the Union's grievance. The matter is now closed.

LOCAL 18 v. INFRASOURCE (Grievance): The Union filed a grievance challenging the employer's decision to end a Union member's employment. An arbitrator was selected, and a hearing date was set. In the interim, the Union was able to negotiate an acceptable settlement. The matter is now closed.

LOCAL 18/Bernard Gray v. CUYAHOGA MUNICIPAL HOUSING AUTHORITY: The Union filed a grievance challenging the employer's decision to terminate a Union member's employment. The matter was referred to arbitration, an arbitrator was selected, and a hearing held. We are scheduled to resume that hearing later this month.

LOCAL 18 v. SOFIDEL AMERICA. (ULP): During negotiations for a first CBA, the employer provided annual bonuses and benefits to all employees except Local 18 members. The Union filed a charge with the NLRB alleging that the employer's actions are an attempt to discourage membership in the Union. The Union dismissed these charges after the parties were able to reach an agreement on a CBA. This matter is now closed.

The Board of Trustees has committed to an ongoing effort to improve the long-term stability of the Health and Welfare Plan, and they have determined that there will be rate changes for retiree and surviving spouse coverage. The new rates will go into effect January 1, 2022. Notices were mailed in October to retirees and surviving spouses regarding the rate changes. If you have questions about your monthly retiree or surviving spouse premium, please contact the Fringe Office. The Trustees appreciate your continued support when they find it necessary to make changes to keep health care coverage available and affordable to the members.

Your Pension Fund is currently paying out \$13.4 million monthly or \$160.8 million annually to 7,456 retirees and surviving spouses. As always, the trustees, staff, investment consultants, and actuaries are continually monitoring the Pension Fund to maintain its financial integrity and viability for the current retirees and the working participants who will retire in the coming years.



District 2 has had a very good work season in 2021. Many members have had great work opportunities and have taken advantage of our Training Centers to not miss a chance at a job due to a lack of knowledge or skill. Updating current skills and learning new ones is the most effective way to insulate ourselves from extended unemployment that can happen due to weather or a change of season. Here are some current and upcoming projects in District 2.

Vernon Nagel has been awarded an intersection improvements project in Van Wert County, which includes a new bridge deck, underdrains, curb and gutter, catch basins, and a new roundabout at the intersection of U.S. Rt. 127/U.S. Rt. 224 and Marsh Rd., which is located north of the City of Van Wert. Construction is tentatively scheduled to begin this spring, with completion slated for late fall.

Helms & Sons recently finished reconstructing S.R. 66 and S.R. 190 in Delphos. New catch basins, curb and gutter, signage, sidewalk, traffic lights, and new asphalt put the finishing touch on upgrading this section of town.

Geddis Paving & Excavating is finishing their minor reconstruction project on S.R. 15 in Hancock County. The company removed the existing intersections of both Twp. Rd. 196/S.R. 15 and Twp. Rd. 198/S.R. 15 and replaced them with cul-de-sacs. Re-grading of the median ditch along S.R. 15 was performed as well to ensure proper drainage. This project kept several operating engineers busy for a few months this fall.

By the time you read this, Eagle Bridge should have completed two bridge replacements on S.R. 698 over Tiderishi Creek in Hancock County. Both bridges

Industrial Resource Group continues to employ a couple operating engineers on the Hardin Solar II Project, maintaining access roads. This 170 mega-watt solar farm is located west of Kenton. Cem-Base performed

As winter 2021 begins in District 3, Kokosing has operators on their two ODOT projects in downtown Columbus. The first is the "2-E" project, where I-70 and I-71 intersect. It's a major reconstruction/realignment with cast in place and MSE retaining walls. There were multiple bridge demos with new, redesigned replacements. Subcontractors have included U.S. Utilities Contractor Co., Lake Erie Construction, Turn-Key Tunneling, Capital City Group Crane Rental, Danbert, K D Complete Clearing, Miller Cable, M P Dory Co., and Phenix Stabilization. The second project is the Broad St./I-71 Columbus Crossroads. This project includes reconstructing the Broad Street Bridge over I-71, the elimination of entrance and exit ramps, lane additions, and retaining walls. Subcontractors include M P Dory Co., Complete General Construction, Armstrong Steel, Paul Peterson Co., and West Fairfield Inc.

Work at The Ohio State University is booming with multiple major projects, including the expansion of the Wexner Medical Center main hospital, the new OSU/ Nationwide Children's Hospital Ambulatory Center, an animal research center, a large greenhouse, and an additional steam/power plant. It was announced that four to five additional projects are slated to start within the next year. George J. Igel & Co. has had several projects on the OSU campus this season. Nationwide Children's Hospital announced that a second tower would be added to its main hospital. This will be a four-year project at the cost of an estimated \$3.3 billion.

Shelly & Sands is busy on a reconstruction project on South Hamilton Rd. This job goes south from I-70 to Refugee Rd. and

includes widening, new sidewalks, box culverts, storm sewer additions, and over 700 structures to be installed.

Distribution and Maintenance work is keeping RLA Utilities, Miller Pipeline, and Northern Pipeline busy with about 50 crews. Columbia Gas announced that they would be nearly doubling their workload, which will increase the need for more operators in the Distribution and Maintenance field. The municipalities around Columbus have been busy with street reconstruction, paving, water line replacements, and sewer upgrades.

In Westerville, Kokosing is working on the Hoover Reservoir Spillway. Strawser Paving will be in the City of Westerville this season. In New Albany, Complete General

Construction has Operators installing a new 42-inch sanitary sewer trunk line. It is more than 4,400 linear feet and has an average depth of 40 feet. Project Mustang has Keller North America working on micro piles. George J. Igel & Co. is digging the footers and has operating engineers spread out across dirt and pipe crews on this long-term project. Operators with Capital City Crane, ALL Crane, and PKX are also working at Project Mustang. Shelly & Sands has operators busy on a North Hamilton road-widening project. R.B. Jergens is building a cell at the SWACO Landfill in Grove City. They have also built a new leach aid pond and rerouted the piping for the leach aid. This project is due to be completed in 2022. The district had no problem staying busy throughout the 2021 season. The weather cooperated, and so did the budgets from the Municipalities, ODOT, and Private Development. With the Amazon Hub still under construction at the Cincinnati/Northern Kentucky International Airport, it has influenced a lot of development in and around the airport, which has kept many of our members really busy, even in the winter months, and it looks like it will be that way for some time to come.

Northwestern Counties

R.B. Jergens is working at the Republic Waste Landfill in Celina. The company is relocating 42,000 tons of trash and moving 50,000 yards of dirt. R.B. Jergens will continue through the 2022 work season on the remaining parts of this landfill closure.

Bluffton Contracting Inc. has finished a new sewer extension for the City of Wapakoneta on Harden Pike; the company laid 2,400 feet of 16-inch plastic force sewer main and had two separate 30-inch jack and boars and directional drilled over 1,000 feet of the main.

The Shelly Company finished their 2021 paving season in the Cities of Bellefontaine and Springfield. In late October, Shelly's milling crews were on the jobs, and the paving crews finished laying the asphalt in mid-November. Eagle Bridge started a bridge reconstruction on I-75 just north of Piqua. Over the late fall, the company built a temporary bridge in the center median of the highway that will allow traffic to be switched in early winter to demo the existing bridge structures. Barrett Paving laid the temporary asphalt for this project. Kinnison Excavating has finished the water

service upgrades for the City of Springfield. The company replaced over 300 lead water services and upgraded the existing water meters. Also working in Springfield over the late fall was A&B Asphalt. The concrete crew was busy replacing sections of existing concrete sidewalk and curbs, then Phenix Stabilization stabilized the existing roadway, and A&B laid the asphalt. Howell Contracting just finished a water main extension on U.S. Rt. 40 in Springfield. The company laid 11,000 feet of 24-inch ductile water main and Precise Boring of Ohio directional drilled 5,000 feet of 12-inch ductile pipe that will allow new developments

along Nation Road. John R. Jurgensen con-

tinues on I-75 in Springfield. Over the fall,

MEDICAL REVIEW

Drug testing – What actually is a refusal?

Unfortunately, a refusal is not always just as simple as not going to a drug/alcohol test. There is a bit more to it than that, and members are regularly surprised when they end up in Local 18's Drug & Alcohol-Free Workplace Intervention Program for the "stupid" rules at the testing facility or other various things that might come up while being tested.

First and foremost, a REFUSAL to take a drug/alcohol test will be reported as a POSITIVE drug/alcohol screen, whether it is a DOT test or a NON-DOT test. If an employer tells you it is time for a drug/alcohol screen, you must comply. It could be for a pre-employment screen, a random screen, a screen due to suspicious behavior on the job, or required due to an on-the-job accident.

The professionals on staff at the testing site make sure that official procedures are followed, not you.

Make sure you follow these rules and requirements when going for and when taking a drug/alcohol test:

- When you are told that you must get a drug/alcohol screen, you must show up for your appointment at the testing facility and show up on time. If you are directed to the collection site, you must show up in a timely manner.
- NO ONE wants to be observed while providing a urine sample. Absolutely NO ONE. Here it is though, the big BUT

 if an employer orders it or if a collector doing their job has a reason to order it on the spot, you MUST be observed. Guaranteed, they do this day in and day out, and it is nothing they haven't seen before.
- When it is an observed test, and they need you to turn around, raise and lower clothing do it they have a reason for it.
- When you are ordered to remove your hat, coat, gloves, coveralls just do it.
- You must take a second test if, by chance, you are ordered to take a second test by the collector or the employer.



- You can't have anything on your body designed to carry clean urine or urine substitute.
- No Adulterating, substituting, or tampering with the specimen.
- Do NOT walk out of the site without permission from the official at the testing site. You CAN NOT leave the testing site before the ENTIRE process is complete and you have been dismissed.
- You must provide enough urine, saliva, or breath to conduct the test. If they say you haven't provided enough, it is not enough.
- If a medical exam is deemed necessary, you must comply.
- You must sign the certification statement to have the test performed.
- You have to cooperate with the testing facility and testing rules – You CAN NOT act in a confrontational manner and act disruptive to the testing process.

The people at the testing sites are the professionals at their jobs, and they need to be allowed to do their jobs as required. If a drug/alcohol test is ordered for you, take the test, and follow the facility rules. When members call in surprised by their recent problems with a contractor and Local 18 and tell me they didn't refuse a drug/alcohol test, all I can do is remind them that drug and alcohol testing is a part of Local 18's Collective Bargaining Agreements. I remind them there is a reason for the testing and that rules need to be followed. I remind them and then get them signed up with Local 18's Drug & Alcohol-Free Workplace Intervention Program. A REFUSAL is a POSITIVE.

The Women's Health and Cancer Rights Act of 1998

On October 21, 1998, the Women's Health and Cancer Rights Act was signed into law. Effective for plan years on or after that date, group health plans, insurance companies and health maintenance organizations (HMOs) offering mastectomy coverage must also cover reconstructive surgery as determined in consultation with the attending physician and patient.

The Health & Welfare Plan takes the responsibility seriously. Coverage includes:

- Reconstruction of the breast on which the mastectomy was performed.
- Surgery and reconstruction of the other breast to present a symmetrical appearance.
- Prostheses and treatment of physical complications at all stages of the mastectomy procedure. This includes lymph-edemas, which are swellings of the hand and arm on the operated side.

These benefits are subject to the same deductibles and coinsurance that apply to other medical and surgical benefits provided under this plan.





Harrod and Lafayette, serving all residents of both communities. The completion date will be October 2022.

Well over \$800 million have been spent on funding the expansion of the North Star Blue Scope Steel Plant in Delta. Rudolph Libbe is overseeing the project and performing the site work. The project has added a furnace and a slab caster to production. Jeffers Crane Service, Capital City, Don Fruchey Inc, Dunbar Mechanical LLC, Henry Gurtzweiler, Inc., and GEM have been brought in as subcontractors. With the addition of the Melt Shop, it is expected that North Star will add 950.000 metric tons of steel to the 2.3 million metric tons North Star already produces annually, an increase of about 40%. Separately, IPS has also picked up a substantial amount of work at North Star that will keep our members busy.

Just off S.R. 109 and the Ohio Turnpike in Delta, Mosser has completed the site drainage and prep work on the \$75 million construction of Nova Tube and Steel's new facility, with Tenmile Creek Excavating performing stabilization for the drives and beautification of the site and Foundation Steel setting the structural steel. Nova Tube and Steel is a Canadian-based company that processes and distributes carbon steel, stainless steel, and aluminum products and operates as an intermediary between primary metal producers and manufacturers. The plant will be 250,000 sq. ft. and will utilize the latest advanced manufacturing technology with Ohio talent to support

the growing demand in the North American market.

In Wood County, Rudolph Libbe is busy with just over \$1 billion of work between two large building projects. The first is an expansion on the 1.1 million sq. ft. First Solar manufacturing facility built in 2018. The 1.9 million sq. ft. addition, with an estimated price tag of \$680 million, had site work start earlier this year. The mass excavation and bulk of the earthwork will be done by Nick Kostecki Excavating. Rudolph Libbe will self-perform the rest of the site work, and they will have Capital City Group in for crane support. This job has an aggressive schedule, but with the large workforce of operating engineers on this project, they are really moving along. Most, if not all, of the walls and temporary roof should be up by the end of the year, with the permanent roof starting the first of the year. This project will have operating engineers working well into December of 2022.

Once this addition is up and running along with the previous two First Solar sites in the area, it has been said that Ohio will be second only to China when it comes to the manufacturing of solar panel materials. Next is the 1.2 million square foot Peloton manufacturing facility in Luckey, Ohio. This project is very similar to the First Solar project when it comes to subcontractors. The major difference is Henry Gurtzweiler, Inc. for crane support with the steel erection. GEM is also on site for the site utilities. This project started in August of 2021 and has a completion date of winter of 2022.

This facility, when it is up and running, will build Peloton bikes and treadmills.

E. S. Wagner continues rebuilding I-75 between Dorr St. and South Avenue. Currently, both inbound ramps are closed to tear out and realign the ramps to enter I-75 from the right lane side, not the left, which will be a major safety improvement. The main objectives of this project are the ramps' reconstruction and widening I-75 from two lanes to three both ways through the area. In normal times, the ramp from the outbound Anthony Wayne Trail to southbound I-75 is used by about 7,555 vehicles per day, while the inbound Anthony Wayne Trail's entrance to northbound I-75 is used by about 6,711. The project is scheduled to be completed in late 2022.

project from Wales Rd. up to Dorr St. in Toledo, Northwood and Rossford is seeing some progress. The five-year mega project will widen I-75 to three lanes in each direction. Work on this project includes:

- Widen and reconstruct I-75 to current standards, including reducing the curve between Wales Rd. and Miami St.
- Reconfigure I-75 interchanges with Anthony Wayne Trail, South Ave., and Miami St.
- Replace I-75 (DiSalle Bridge) over the Maumee River.

The project, which is running on schedule, is expected to be completed in 2023.



Miller Brothers Construction continues work on a three-span steel beam bridge to replace the ailing Marengo Street Bridge built in 1915. The bridge closed to vehicular traffic in April 2016 because of its deteriorated condition. Construction is expected to be complete by the end of the year.

A recently released project called Phase 2 will bring a number of other amenities such as:

- A 9,000 square foot market hall.
- An ice-skating ribbon along with six cabanas.
- A hammock village.
- A man-made pond.

Union contractors awarded on this project are Delventhal, Mosser, Foundation Steel, and Earl Mechanical.



Working on a new factory for Dupont in Circleville, Early Construction and Stevens have had members busy in Pickaway County. Gavin Power Plant has several operators working for Gallia Fuels treating the coal, with Enerfab doing the maintenance. Beaver Excavating and AMS are working on the landfill expansion and hauling the ash at the Kyger Creek Power Plant.

Multiple contractors are working at the Piketon A-Plant on landfill cells and demolition. In Ross County, Axis Civil has a culvert replacement. Fluor and Ison Excavating are both working on maintenance at the Coke Plant in Franklin Furnace. Axis Civil will be replacing a culvert on S.R. 677 in Vinton County.

In the town of Sunbury, Helms & Sons has Phase 1 of a new sewer line at Walnut Creek. Park Enterprise and Trucco Con-

struction both have residential site work in Delaware County's emerging housing market. George J. Igel & Co. has two pipe crews at the Jerome Village housing development installing several miles of water and sewer line.

Operators with Kokosing are working on the Marion Wastewater Treatment Plant. Kokosing will be repairing multiple bridges on U.S. Rt. 33 in Union County. Miller Pipeline crews have been scattered throughout Union and Delaware counties installing new lines for Columbia Gas. Lake Erie Construction has both Wyandot and Crawford County guardrail replacement packages.

Complete General is on a bridge replacement on S.R. 266 near Stockport. ALL Crane, PSC, and George J. Igel & Co. have operators working in Hocking County on

Meanwhile, Shelly & Sands is getting started working on rebuilding and widening S.R. 60; this two-year project starts at Duncan Falls and finishes at the Morgan County line. In Zanesville, at the Eastpointe Business Park, Barton-Malow and Stevens Engineers have members installing water, storm, and sanitary lines as well as setting steel and furnace components at the AMG Vanadium project, which is due to be completed in early 2022. George J. Igel & Co. is on site driving piling, and Mascaro Construction has operators setting steel and digging footers. Rock River Construction is hard at work on a new sanitary sewer mainline in Nelsonville. Trucco Construction has operators installing new water lines, storm and sanitary for the Stimson Ave. rebuild in Athens. Fields Excavating has two pipe crews busy

working on the U.S. Rt. 50 sanitary project that goes from Albany to Athens. the building. Also working on this project is Viking Erectors. They are setting the insulated panes on top of the precast walls, and in early fall, Piqua Steel set the electrical transformers for this facility.

R.B. Jergens is in the final phase of construction on U.S. Rt. 40 by the Dayton International Airport. The company finished the final concrete exit ramps in mid-November. In the spring, John R. Jurgensen will finish this project, laying the final course of asphalt on I-75, just north of Vandalia in late November. Eagle Bridge had completed the demolition of the CSX Railroad Bridge over the interstate. This bridge has been abandoned for years and needed to be removed due to parts of the bridge falling into traffic. Piqua Steel was on this project in late October, removing the steel I-beams. Barrett Paving finished its 2021 paving in Huber Heights. Welfle performed the asphalt milling, and Blueridge Custom Sweeping performed the power sweeping. Barrett then laid the topcoat of asphalt to complete this project. On I-75 at Edwin C. Moses, The Ruhlin Company has started Phase 4 of this highway project. Northbound traffic was moved to the inside lanes of the roadway in mid-November, allowing the company to remove the outside lanes during the winter months. The bridge over Edwin C. Moses on the outside lanes will be demolished, and Ruhlin will then start the reconstruction of the bridge. John R. Jurgensen has finished the 2021 asphalt project in the City of Dayton.

Over the fall months, the company milled and filled over 25 city streets. Also in Dayton, Eagle Bridge has finished the twoyear bridge replacement on 3rd St. over the Great Miami River. This bridge project has kept a number of Local 18 contractors busy over the last two years, including Ebony Construction, who milled the old bridge deck and layed the new asphalt for the project. Also, Tri-State Concrete poured the sidewalks and new approaches.

Capital City Crane set the concrete beams over the river, and Security Fence installed the lighting and traffic signals. The reopening of this bridge in December will allow travel from the west side of the river to reach downtown more efficiently.

Distribution and Maintenance

Center Point Energy has been keeping a number of Local 18 contractors busy in the Dayton area over the last year. KS Energy is working on a number of projects in Dayton. On Amherst Place, they are replacing 10,000 feet of 2-inch gas main and installing 118 new residential services on Oxford Avenue. The company has installed 50 services and replaced 5000 feet of plastic gas main. Miller Pipeline is also working on a number of jobs in Dayton as well. On Catalpa St., Miller Pipeline is laying 5000 feet of 2- and 4-inch plastic gas main and is replacing 107 services. On Findlay St., Miller is replacing an 8-inch gas main and is running new services to the industrial buildings in the area.

Shop

At the Ohio CAT shop in Troy, the mechanics have been working on a certified power train rebuild of a Caterpillar 770 *continued on page 29*

End Dump. Over the fall, the machine was completely disassembled, and all the power train components were rebuilt. After the frame was repainted, the rebuilt transmission and engine were reinstalled. This kind of rebuild gives Ohio Caterpillar customers a factory warranty on the machine at a discount rate versus buying a new machine. The Columbus Equipment Shop in Huber Heights is also working on a variety of machines for its customers. The mechanics are installing attachments on excavators that allow operators to drive sheet piles and forestry attachments to pick up logs and cut them to length. They are installing flotation tracks that enable an excavator to float on water as well.

Southwestern Counties

In Preble County, John R. Jurgensen will be returning this season to the I-70 resurfacing project that runs through Preble County to finish the paving of the eastbound lanes. Some of the subcontractors for the project are Bansal, with the installation of new lighting at the entrance and exit ramps, M P Dory Co. is installing all the new guardrail, and Donegal Construction Corporation performed the milling of the old asphalt on this project.

Barrett Paving has completed several projects for ODOT in Preble County. One is on U.S. Rt. 127 that started on the north side of the City of Eaton and continued north to the county line. The second one started on S.R. 732 east of the City of Eaton through Washing and Gasper Townships, which included milling and resurfacing these routes with new asphalt. Welfle performed the milling and Blue Ridge Sweeping doing the cleanup.

Barrett Paving has also completed the Preble County Engineer asphalt resurfacing project for 2021 on various county roadways. In Butler County, there have been two new roundabouts installed replacing the old intersection in the area. Ford Development has performed the work at the old intersection at Butler Warren Rd. and Socialville Foster Rd. and W. Chester Rd. that aligned all three roads into the new roundabout. Subcontractors on site were Elex Electrical installing the new street lighting and John R. Jurgensen performing the paving on this project. In Trenton, the heavily used four-way signaled intersection at Wayne Madison Rd. and Trenton Rd. is being replaced with a new roundabout by R.B. Jurgens as the General Contractor. The subcontractor was Landview Services doing the reseeding, sod, and restoration. John R. Jurgensen had laid the new asphalt on this project as well.

In Warren County, in the spring, Barrett Paving will be starting back to work on the reconstruction of Miami St. in Deerfield Township. The scope of work will include a complete street replacement with all new curb and sidewalk and new storm sewer, and the water main will be replaced by Donald W. May Contracting. Barrett has also completed a street rehab project on Lebanon Rd. in South Lebanon with new curb and sidewalks that were installed by Oglesby Construction.

Rack & Ballauer has completed the intersection of S.R. 741 and Kings Mill Ave. in Mason. This project was to help ease the flow of traffic in this intersection. This intersection was changed from a four-way intersection to a three-way intersection, including widening the lanes and adding additional turn lanes. Elex Electrical installed the new traffic signals and street lighting, Oglesby Construction did all the concrete curbs and sidewalk, and Landview Services did all the landscaping and restoration for this project.

Shops

The Southeastern Equipment Shop in Monroe is staying active with prepping new equipment for sales to customers, along with warranty and service work. The field mechanics are staying busy working on the machines that don't come into the shop.

The McLean Company in West Chester is very busy with service and repairs to asphalt paving equipment and milling machines getting ready for the 2022 season. The shop and field mechanics for RECO Equipment in Monroe are extremely busy servicing, maintaining, and repairing scrap handling equipment all over western Ohio and down into Kentucky.

The Barrett Paving Shop is very active getting ready for the 2022 paving season, working on pavers, track hoes, and dozers. *continued on page 30*

At the Cleveland Cliffs Steel Mill (AK Steel) in Monroe, McGraw Kokosing is performing routine maintenance for the mill, including manlift rentals and surveying for the proper alignment of the rollers and other equipment that flatten the steel during processing. There are several other maintenance contractors at the mill as well. Brand Energy and Graecor are also performing building, grounds, and machinery repairs inside the plant, keeping many of our operators busy even during the winter months.

Vesuvius, USA is running several shifts with the degassing process that sprays a gas into the molten steel in the kettle to help remove excess carbon to keep the iron from getting too brittle. Over in the slab yard, TMS International is performing a procedure known as scarfing the slabs. It is a process that involves using a torch that cleans the surface of the steel slabs of impurities, which is the last step before it goes to the roller mill to be made into coils.

KT-Grant has been in the mill for many years performing the cleanup and knocking out of the slag that has stuck to the kettles, troughs, and or spilled out during the steel making process.

In the transportation facility, Maxim Crane is on site with loader maintenance for the plant. Bulk transport mechanics are busy with repairs to the pot haulers, reach stackers, and other material handling equipment for the mill.

Over at the onsite coke producing facility, MPW Construction Services is manning the locomotives and conveyors that handle the coke.

Across the road, on the south side of the mill, Stein is operating the slag yard, handling and recycling all the slag that is a byproduct of the steelmaking process.

Eastern Counties

In Highland County, Castle Contracting continues work on the 300-Megawatt, 2,000-acre Highland County Solar Farm. Castle Contracting is doing the site clearing, dirt-moving, and trenching for underground electrical lines for this project. Also, in Highland County, Distel Construction has completed work on installing 1,000 feet of 8-inch water line in the town of Hillsboro.

In Clinton County, John R. Jurgensen continues work on the U.S. Rt. 22 reconstruction project. This project has John R. Jurgensen installing 2,000 feet of new water main, 3,000 feet of new 12- to 60-inch storm piping, 70 new catch basins, and manhole structures. Oglesby Construction will be on site to install 2,500 feet of new curb and gutter, along with new bike path pavement.

In Greene County, John R. Jurgensen has completed work on the U.S. Rt. 35 Super Street project. John R. Jurgensen widened both the east- and westbound lanes of U.S. Rt. 35 from Factory Rd. to Trebein Rd. The project consisted of excavating the existing highway on the east- and westbound lanes and installing 5,000 feet of new 12- to 42inch storm piping. Shelly & Sands completed reconstruction of the bridge structures. Mt. Carmel Stabilization completed the soil stabilization, Bansal Construction completed the electrical work for the traffic signals. John R. Jurgensen has also completed work on Phase 1 of the four-lane resurfacing and bridge reconstruction of I-675. John R. Jurgensen milled and paved 15 miles of new asphalt. Complete General Construction assisted with the bridge reconstructions, working on bridge overlays and new reflection walls on 18 bridges.

Also, in Greene County, R.B. Jergens completed work on Phase 1 of the County Line Road widening project in Beavercreek. This project consisted of the installation of one-half mile of 12-inch storm piping, 20 catch basins and manhole structures, one mile of curb and gutter, one-half mile of five-foot sidewalk to the east side of the project, and a half-mile of 10-foot sidewalk to the westside of the project. John R. Jurgensen completed the paving on the project.

In Brown County, Brown County Asphalt completed the S.R. 125 resurfacing project in Hamersville. This project consisted of *continued on page 31*

100,000 square yards of milling and 4,100 cubic yards of new asphalt replacement. The company has also completed the Brown County Asphalt Paving Program, which consisted of milling 1,300 cubic yards on various county roads and replacing it with 1,300 yards of new asphalt.

In Clermont County, Rack & Ballauer completed the major widening of Old State Route 74 in Eastgate. Local 18 members moved thousands of yards of dirt, installed new curb and gutter, along with 6,000 feet of new storm piping, manholes, and catch basins. RLA Utilities moved the natural gas pipeline for this project, and Barrett Paving and Materials completed the paving on this project. Also, in Clermont County, MCM Management completed the demo project at the old Beckjord Power Plant in New Richmond. The 11 members who worked on this project safely removed 1,000 tons of various types of metal and over 100,000 yards of crushed concrete. On Beechmont Ave., Kokosing Construction is busy completing the Beechmont Bridge Project. Local 18 members working for Kokosing have completed placing 23,000 yards of dirt fill and installed 3,200 feet of steel piling. Kokosing will also be installing a 70-foot by 11-foot by 16-foot box culvert that will serve as a bike path under the ramp that will

connect the Beechmont and Lunkin Airport bike paths. Also, in Clermont County, Barrett Paving completed the 2021 Road Resurfacing Project. This project consisted of milling 62,000 square yards of asphalt and replacing it with 37,000 tons of new asphalt.

In Eastern Hamilton County, Barrett Paving has completed the Broadwell and Mt. Carmel Road Milling and Paving Project. Barrett Paving milled 42,000 square yards of existing asphalt and replaced it with 9,000 tons of new asphalt.

Distribution and Maintenance

Miller Pipeline completed the installation of 16,000 feet of 4- and 8-inch natural gas pipeline on Maple Ave., Redwood St., and Middle St in Fairborn. Miller also has 45 business and residential services to connect.

Mainline Pipeline

Minnesota Limited has just about completed 9.5 miles of 20-inch lift and lay natural gas pipe from the village of Cedarville to the township of Wilberforce in Greene County. This has kept 12 Local 18 members busy.

Shops

The Ohio CAT - AG shop in Washington Court House continues repairs and services to various types of farm machinery to help farmers prepare for the spring planting season year.

John R. Jurgensen Shop in Sharonville has kept approximately 40 mechanics busy with repairs and services to numerous pieces of

equipment well into the late fall and early winter to help them get a good start for their busy upcoming work season.

Hamilton County and Northern Kentucky

2021 has been a great year for our members working in the Hamilton County and the Northern Kentucky counties of District 4/5. District 4/5 has been known historically for being a district heavily supported by Heavy Highway, Building, and Distribution work. This year we added major pipeline projects usually not found in abundance in this area.

InfraSource began work on the Duke Corridor project in the winter of 2021. Phase 1 of the project consists of 68,000 ft. of 20-inch new lay gas line that runs from the City of Blue Ash through the Cities of Evendale, Reading, and Cincinnati and eventually ends at a metering station in the City of Norwood. This project provided thousands of work hours for our members and employed over 60 operating engineers. While InfraSource performed the station installations and most of the pipework, they relied on Aaron Enterprises to do most of the boring under roads and railroads and all the directional drilling on the project. Aarons Enterprises provided work for a dozen of our members and recently completed their work on the project. Mid America Services performed the hydro-excavating on the project. This project also created a lot of work for our local contractors. Badger Daylighting assisted with the hydrocontinued on page 32

excavating on this project as well several other projects in our district. Queen City Blacktop and Rack & Ballauer are the paving contractors working on the project; Tri-State Concrete and Oglesby Concrete are doing concrete restoration, with Andis LLC clearing the overburden on the project and Maxim Crane performing the heavy lifting. RLA Utilities, a District 4/5 distribution and maintenance contractor, is working in Cincinnati near the Corridor project locating utilities and preparing transmission gas line for future Duke projects.

Walsh Construction is getting close to wrapping up the I-74/I-75 interchange in Cincinnati. The job is expected to complete major construction by late December, with only minor work lasting into 2022. This project provided work for many of our local contractors as well as several contractors from other states. John R. Jurgensen is performing the paving on the project. Security Fence is performing the electrical work, along with the guardrail, fencing, and signage. Maxim Crane did the big crane work. The job, at its peak stages, employed over 50 operators, including the various subcontractors who performed work on the project.

Up the road from the I-74/I-75 interchanges project, Great Lakes Construction

and Keller North America repaired the ramp slippage from Colerain Ave. to I-74 West in Cincinnati. The road was secured by improving the drainage system and installing a tie-back system to stabilize the slope and prevent the soil from future erosion.

Complete General Construction is busy expanding the east and west ramps of U.S. Rt. 42 from I-275 in Hamilton County. The redesign of the ramps included traffic signal relocation, also performed by Complete General, along with drainage upgrades. Complete General is also replacing a 66inch culvert on nearby Hauck Rd. This culvert improvement should keep members working well into the winter months. Complete General is also rehabbing the bridge on Springdale Rd. over I-275 in Colerain Township.

R.B. Jergens is working in Blue Ash on three roundabouts. These roundabouts are designed to ease congestion and improve traffic at the intersections of Reed Hartmann Hwy., Ronald Reagan Hwy., and Hunt Road. The roundabouts will all be tied together with decorative concrete for added aesthetics in this heavily traveled area. John R. Jurgensen is responsible for paving on the project. Future phases of the project will also involve some relocation of water and sewage piping as well as drainage improvements.

Eclipse Construction is working near Kilby Rd. in Harrison. The highway began eroding and was in serious need of repair to prevent further damage to the driving surface. The repair took several months and provided work for several of our members. Brucon Excavating is also busy in the area installing gas line for Duke Energy. Brucon is a newly signed distribution and maintenance contractor.

Northern Kentucky

Local 18's jurisdiction in Northern Kentucky consists of Boone, Kenton, Campbell, and Pendleton counties. With the recent addition of the new Amazon warehouse at CVG Airport, which is still under construction, the Northern Kentucky expansion has been unprecedented. Kokosing *continued on page 33*

Construction recently completed the first phases of the project, which employed dozens of operating engineers in the project's excavation, with help from Trumbull Construction. The project also made several upgrades to the airport to help with the extra air traffic the airport is experiencing.

New runways at CVG Airport had to be added for the additional air traffic. The Harper Company provided the concrete paving on the project. Harper provided over 500,000 square yards of concrete, 15,000 linear feet of drainage and 430, 000 tons of aggregate base on the project. Bansal Construction was key to the successful completion of the project by providing extensive electrical work on the project. Bansal installed the taxiway edge and runway lighting. They also installed the instrument landing systems along with related cabling, including manholes and much more. Spartan Construction helped with the excavation and draining on the project. Blueridge Custom Sweeping helped keep the project clean and safe for both the workers and the general public commuting in the area.

Michels Pipeline recently completed a 20-inch gas pipeline that ran from Florence to Hebron, KY. The project lasted several months and employed 20 operating engineers. Case Boring provided the boring on the project, and Right-A-Way Clearing cleared the right-of-way for the new lay pipe. Over on Houston Rd. a few miles away from the Michels project, Henkels and McCoy performed a 490 ft. road bore of 12-inch pipe under Houston Rd. to replace an existing 16-inch gas line that was being abandoned. InfraSource is also busy

working on natural gas lines in Northern Kentucky. This project included maintenance, anomaly digs, line relocating, and valve replacements. This project is expected to be completed at the end of 2022.

Scholarship Application Period

The Education and Safety Fund scholarship application period runs from January 1, 2021 through April 1, 2021. Applications are available at the Fringe Benefit Office, or at any Local 18 district office, as well as on Local 18's website, by clicking on the "FRINGE BENEFITS" link below the "MEMBERS" tab, or by going directly to https://memberxg.gobasys.com/OOEFBP.

Scholarships are available to members of Local 18 who are eligible for benefits from Ohio Operating Engineers Health and Welfare Plan, or who have at least one month of eligibility in the twelve-month period immediately preceding the date that the application is received at the Fringe Benefit Office. Qualified dependents may also be eligible for a scholarship if they meet the requirements established by the Board of Trustees.

Special Dependent Scholarship Award

Once again, the Education and Safety Fund Trustees will be awarding a special scholarship to an eligible dependent child with a declared major in a construction industry-related course of study. If interested for consideration of this special award, the Trustees require that a two-page, double-spaced, essay is submitted, along with your scholarship application and proof of your major. The essay should include answers to the following:

- 1. What is the reason you are pursuing a construction industry-related major?
- 2. Who or what influenced you to pursue a construction industry-related major?
- 3. What is your connection to the IUOE Local 18?
- 4. What are your long-term plans?

If you have submitted an essay in a prior year, please be sure to write a new essay. All scholarship applications and essays must be submitted to the Fringe Benefit Office by April 1, 2022.

Temporary Extension of Deadlines Due to COVID-19 National Emergency

The federal government announced that the country is under a COVID-19 National Emergency starting March 1, 2020. The period between March 1, 2020 and the 60th day after the announced end of the COVID-19 National Emergency will not count against certain deadlines under the Ohio Operating Engineers Health and Welfare Plan and the Ohio Operating Engineers Pension Plan. The extension applies to deadlines to file a claim or appeal, enroll a new spouse or child, report COBRA qualifying events and to elect and pay for COBRA under the Health and Welfare Plan. The extension also applies to deadlines to file a claim or appeal under the Pension Plan. This may give you a longer time to take certain actions. Please contact the Fringe Benefit Programs Office if you have questions.


