Dues Schedule

Any member of Local 18, 18A, 18B, 18C, 18D, 18G, 18RA or 18S who does not have his/her current dues paid may be suspended. Dues are payable on a quarterly basis on the first day of each quarter (30-day grace period), with the exception of 18D and 18S, to be paid on a monthly basis.

The quarterly and monthly dues schedule for Local 18 and its Branches and Owner/ Operator members is as follows:

Contributions or gifts to I.U.O.E. Local 18 are not deductible as charitable contributions for federal income tax purposes.

*The Executive Board, at its January 25, 2020 meeting, approved a resolution to Article VIII, Section 1, of the Bylaws, decreasing the administrative dues to 2.5% of gross wages for all members of Local 18, 18A, 18B, and 18RA. The Executive Board also approved a decrease of administrative dues to 1.5% of gross wages for 18C equipment shop members. Local 18C Quarry and Sand & Gravel Pit members, Local 18D, Local 18G, and Local 18S members dues will remain unchanged. The decrease is effective on April 1, 2020.

I was always told by the retirees and the journeymen and journeywomen, "the key to steady work is being versatile." The ability to operate multiple pieces of equipment efficiently, obtain numerous certifica-

tions, and carry a current and clean CDL license are the keys to steady work. Do not let any downtime go to waste; make every effort to sign up for classes to upgrade your skills every year. It could

The work outlook for District 1 for the upcoming season is good. Please take advantage of the many classes the training centers offer to improve your skills and maintain current or get new certifications in the off-season.

In Northern Cuyahoga County, in Cleveland, Eclipse Construction has the replacement of the steps for the new pedestrian bridge at the North Coast Harbor, Marra Services has the storm sewer repairs on East 78th St., and Independence Excavating and Vantastic Crane Service are working on the addition for Minute Men on Cedar Rd. Also, at the Northcoast Harbor is Eclipse Construction, making concrete repairs to the pedestrian bridge. ALL Erection & Crane is assembling a new gantry for the Great Lakes Shipyard. Keller North America and Independence Excavating started on the Sherwin Williams project in Downtown Cleveland.

Terrace Construction has valve and hydrant repairs throughout the City of Cleveland. Terrace Construction is also replacing the waterline on Anderson Dr. in South Euclid. Miller Cable has the replacement of electrical conduit at North Marginal Rd. in Cleveland. HEALTH TIPS

Is a gym membership worth it for you?

It's December as I'm putting together the Health Tips for February, and the first thing that came to mind for the new year and January 1st is the New Year's Resolutions that everyone makes as they are facing the new year and all of the ads for the gym memberships. They offer discounts to get more people to join in the new year. I'm wondering how many people join and how many people maintain their memberships after a couple of months. My guess is that the ones that truly benefit are the gyms, financially. I know I got sucked into it one time, many years ago, and back then, they had start-up fees and yearly contracts. I failed miserably and keep that in mind now every year as I'm thinking about what to improve in the new year.

Should you join a gym or not? That's a question you may ask if health and weight loss are top on your list for the new year.

There are some obvious benefits/pros in joining a gym:

- All kinds of equipment at your disposal, new and improved stuff - with all of that equipment, you can really get a good workout and change it up when you want/need to
- Trainers on hand to teach you how to use equipment properly and safely
- Scheduled classes you can really change up your cardio workout, stay on a schedule, and even make it a social event
- People are always there if you are social or need that encouragement – then it is a positive
- Some gyms may offer tanning, a spa, and/or massages – a nice way to end your workout

All those benefits are pretty obvious, but even more obvious is this statement: they are benefits IF YOU GO AND USE THE GYM REGULARLY. If you don't go, there are no benefits to that gym membership.

Of course, there are obvious downfalls/ cons to joining a gym:



- There is a start-up fee (usually waived or discounted at the beginning of the year) and monthly fees
- Sometimes there is an agreement keeping your money tied to them for months, whether you continue using it or not
- Typical work out times, before work and after work, the gyms are overly crowded

 wait times for equipment, more people there to watch and distract you
- When you allocate time for your workout, you have to add in travel time – certain times it may be difficult enough to allocate time for a workout
- People are there always some people don't want to be watched or seen as they struggle to work out and as they sweat

Some gyms have opened up that are so convenient, their hours, their low start-up fee, their locations in neighborhoods everywhere, and that is all fine and dandy if you use them. (Even the low-cost ones are taking your money, and it is a waste if you aren't using the gym regularly). The truth of the matter is, you can discipline yourself and get a good workout without a gym and a gym fee, and you don't have to spend hours at a time to get fit. Try these basic things first, and then once you have built up to a full workout and have disciplined yourself, maybe then try one of those convenient, low-cost gyms to add to your workout regimen.

- Start by picking a time to work out. Set the time and stick to it, so it becomes a habit. I chose mornings, before work.
- Choose a simple workout to get started. I started by using an exercise trampoline, it's small and doesn't take up much space, and the workout can be pretty varied on it.
- Set a timer for five minutes and do your chosen workout every day or as often as you want to do your workout, and then every week, add more minutes daily. I like Monday thru Friday for a scheduled workout and then doing a fun activity over the weekend like a hike. I chose five minutes just to get the habit started, so I wasn't discouraged mentally. I exercised 5 minutes daily and did it until those 5 minutes weren't a chore. I then added time to it, increasing it weekly, up to 10, to 15, to 20, etc., until I got to my full workout time.
- Once I got to a duration I was comfortable with, I would add more in all day long to keep my body moving: lifting full cans or bottles, going up and down steps repeatedly, breaks every hour to stretch and for little bursts of exercise, walks at lunch, long or short, whatever time was available, and even walking or jogging in place while watching a show. I eventually added the low-cost gym membership to keep it interesting and to add more weights, but with COVID shutdowns, I found some inexpensive used equipment, not large quantities and nothing fancy, and took to my basement instead of the gym.

What I've personally found, it all can be done inexpensively and with not much room taken up at your home if you want to become more fit and health-conscious. If there is a will, there is a way!

Remembering Premo P. Panzarello

1948 - 2021

As we said goodbye to the year 2021, Local 18 received the unfortunate news that we had to say goodbye to retired staff and officer Premo P. Panzarello after his battle with cancer.

Premo was a 54-year member of Local 18 out of District 1 who began his career in the very first apprenticeship class in 1971. While out in the field, he worked as a mechanic, mainly in the asphalt industry for a number of years, and also served as an executive board member.

In 1998, Premo joined the Local 18 staff as a business representative and was responsible for the east side counties of the District 1 area. During his career at Local 18, he moved up through the ranks to become the Director of Organizing in 2004. Upon assuming this responsibility, he was tasked with managing a full-time staff of organizing representatives overseeing the entire State of Ohio and the campaigns Local 18 was pursuing. Premo was always involved in everything his staff was doing and constantly pushed for 100% of the market share. During his career, he and his staff were responsible for signing up close to 700 new contractors to an agreement with Local 18.



To this day and long into the future, the hard work and efforts that Premo was responsible for will continue to employ hundreds, if not thousands, of his brother and sister engineers of Local 18.

Working his way through the ranks of his day-to-day position was not the end of his accomplishments while on the staff of Local 18. Premo served in various officer positions and was elected to conductor, treasurer, and financial secretary during his 17 years on staff. Premo was well known by virtually all of the signatory contractors in town as well as the non-union contractors. He was also well known across the entire IUOE and the members of this great organization.

I was initially hired to the staff by Premo and worked alongside him every day, pursuing the work in the oil and gas industry. At first, he was a fellow operator and coworker, but he definitely became a close friend to the entire staff at Local 18. Most of the current staff and officers worked with or for Premo over the years, and we all still use the term "Premo Trained" every day. There was no one better at reminiscing about working out in the field than Premo, and he could always one-up your on-thejob story no matter how hard you tried.

I know I speak for the entire staff when I say that it was an honor and privilege to have worked with and to have gotten to know Premo over the years. He was one of a kind, and he will be missed by us all. We will continue our organizing efforts with a goal of 100%, just like Premo taught us!







Scholarship Application Period

The Education and Safety Fund scholarship application period runs from January 1, 2021 through April 1, 2021. Applications are available at the Fringe Benefit Office, or at any Local 18 district office, as well as on Local 18's website, by clicking on the "FRINGE BENEFITS" link below the "MEMBERS" tab, or by going directly to https://memberxg.gobasys.com/OOEFBP.

Scholarships are available to members of Local 18 who are eligible for benefits from Ohio Operating Engineers Health and Welfare Plan, or who have at least one month of eligibility in the twelve-month period immediately preceding the date that the application is received at the Fringe Benefit Office. Qualified dependents may also be eligible for a scholarship if they meet the requirements established by the Board of Trustees.

Special Dependent Scholarship Award

Once again, the Education and Safety Fund Trustees will be awarding a special scholarship to an eligible dependent child with a declared major in a construction industry-related course of study. If interested for consideration of this special award, the Trustees require that a two-page, double-spaced, essay is submitted, along with your scholarship application and proof of your major. The essay should include answers to the following:

- 1. What is the reason you are pursuing a construction industry-related major?
- 2. Who or what influenced you to pursue a construction industry-related major?
- 3. What is your connection to the IUOE Local 18?
- 4. What are your long-term plans?

If you have submitted an essay in a prior year, please be sure to write a new essay. All scholarship applications and essays must be submitted to the Fringe Benefit Office by April 1, 2022.

Temporary Extension of Deadlines Due to COVID-19 National Emergency

The federal government announced that the country is under a COVID-19 National Emergency starting March 1, 2020. The period between March 1, 2020 and the 60th day after the announced end of the COVID-19 National Emergency will not count against certain deadlines under the Ohio Operating Engineers Health and Welfare Plan and the Ohio Operating Engineers Pension Plan. The extension applies to deadlines to file a claim or appeal, enroll a new spouse or child, report COBRA qualifying events and to elect and pay for COBRA under the Health and Welfare Plan. The extension also applies to deadlines to file a claim or appeal under the Pension Plan. This may give you a longer time to take certain actions. Please contact the Fringe Benefit Programs Office if you have questions.




